Tree type - Spruce (*Picea abies*)
Approx Height - 12m
Approx Spread - 5m
Location - Left hand boundary, neighbours tree (18 Eastbury road)
Service - Section dismantle
Work required - Section dismantle tree to ground level. Cut stump as close to tree's current ground level as possible and leave in the ground.
Reason - As per customers wishes

Tree number - G1
Tree type - 2x Dead Trees
Approx Height - 4-6m
Location - Right hand boundary of drive, see map
Service - Fell
Work required- Fell as close to tree's current ground level as possible and leave the stumps in the ground
Reason - Trees dead standing, to tidy and make safe

Tree number - T2
Tree type - Cypress (*Chamaecyparis lawsoniana*)
Approx Height - 12m
Location - Left hand boundary of driveway, see map
Service - Prune
Work required- Remove lowest limb growing over the drive as close to main stem as reasonably possible.
Reason - to give clearance to driveway

Tree number - H1
Tree type - Cypress (x *Cupressus leylandii*)
Approx Height - 5-8m
Location - Northern boundary of site shared with 12 Pines Close
Service - Hedge Reduction
Work required- Reduce and level height at around 5m from ground level (roof peak of clients extension)
Reason - To allow more light to adjacent gardens and ease maintenance

Tree number - H2
Tree type - Cypress (x *Cupressus leylandii*)
Approx Height - 5-6m
Location - Eastern boundary of site shared with 14 Pines Close
Service - Hedge Reduction
Work required- Reduce and level height at around 5m from ground level (roof peak of clients extension, southernmost section reduced to this height on neighbours side)
Reason - To allow more light to adjacent gardens and ease maintenance

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
