We would accept a reduced set-back but this means you will need to provide refuse storage in the front garden since there'd be limited access to the rear down the side.

We would accept 1 parking space for the new two-bed dwelling. This would be in accordance with the local plan where only one would be required for a one or two-bed unit. The existing 3-bed would need to retain the 2 spaces.

Dear Mr Wells and Mr Shanahan

I understand that you wish to build a new dwelling and are seeking preapplication advice.

I can see that three applications for a new dwelling have been previously refused, principally due to the impact on the character of the area.

I have reviewed the previous refusals and two appeal decisions. My recommendation for an application that may be looked upon more favourably is to replicate the proportions, scale and appearance of the existing dwellings. Specifically this would be:

- The new dwelling needs to be attached to form a terrace. The street is characterised by consistent spacing between the pairs of semi-detached homes. A detached dwelling cannot duplicate this given the plot width.
- The plot width of the new dwelling should be the same (or as close as practicable so that any variation is visually negligible) as that of No. 2 and the other dwellings on the road. This means that the new home width would be the same as the other dwellings and the appearance can be duplicated with the same three windows, same ground floor fenestration etcetera. In other words the new home needs to look exactly the same. However it is important that the side elevation is not splayed, this would be too conspicuous in the street scene. It needs to be straight like the other dwellings.
- As with the advice above, the front building line and the principal rear building line needs to be the same as No. 2 so that this reads as a terrace of three dwellings. It may be possible to add a small single story rear extension and small rear roof dormer if additional floor area is needed to meet minimum GIA requirements.
- The materials, fenestration design and overall design needs to match the other adjoining and adjacent dwellings.

The above are the key matters, however I note that there have been other reasons for refusal raised. To address these I would recommend that:

- You use the existing dropped kerbs and don't seek to widen these
- There should be enough clearance within the forecourts of both dwellings for pedestrians to access the entrance to each house
- Ensure that the garden space for both homes complies with at least 60sqm (for a 2-3 bedroom home) or 100sqm (4+ bedrooms) and are genuinely usable and of good quality. These should take the form/layout of a standard lengthy rear garden to mimic the typical garden layout in the area.
