> Thank you for your time just now over the phone. It was good to discuss the case with you and we are pleased we can agree a way forward on this site. We hope we can achieve this quickly.

> Please can you ask your agent to re-submit the application with the access issues resolved. What we need to address are:

> 1. Step free access into the dwelling is required and details should be submitted to show this.

> 2. The entrance level plan does not show an entrance level WC. A suitably sized and designed cubicle should be shown on plan to meet the provisions set out in section 2.27(c) of Approved Document M, volume 1 (2015 edition).

> 3. Particular attention should also be paid to the entrance lobby arrangement and to spatial requirements within the bedrooms, bathrooms and kitchen area. The plans should be amended accordingly to demonstrate compliance with the technical specifications within Approved Document M to the Building Regulations (2015 edition).

> This will resolve refusal reason 2. A planning statement can also be submitted to resolve the first reason for refusal, taking on board previous advice from Katie Crosbie (copied).

> We would be happy to meet with you to discuss this further if you have any questions. However, if you want to resubmit, we can do this during the course of the application if needed. Katie is going to be the case officer for the resubmission.
