Reason - Trees have a noticeable sail affect and are over extended next to the road side, reducing in height to relieve bio mechanical stresses on the trees and help prevent failure in the near future

Approx. Diameter at 1.5m - 0.4-0.5m
Approx. Height - AddDetail

Work Required - Section dismantle tree to near ground level
Reason - Trees are showing poor vitality with deadwood throughout the crown, trees also have weak unions towards the base of the tree should these fail would land in neighbouring gardens and on the house. Given the above I would recommend removal of the trees
Priority Code - On

Tree number - G2 stump grinding
Location - Rear garden no.26
Approx Diameter - 0.5m
Service - Stump Grinding
Work required - Grind out the stump to a depth of approx. 200mm below the stump's current ground level and leave all grindings. Please note in-fill grindings mound will be left above ground level to allow for settling
Reason - As per clients specification

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
