## Description of Proposed Works

Please describe the proposed works

This application seeks planning permission for a 6m ground-floor single-storey rear extension at 13 Berwick Avenue. The property has an existing 3.5m single-storey rear extension, and the proposal is to extend this by an additional 2.5m, resulting in a total extension length of 6m. This extension will align with the rear extension at the adjoining property, 15 Berwick Avenue. Pre-application advice was sought from the local planning authority, and positive feedback was received. In response to this advice, the proposed extension has been designed to maintain the existing 3.5m structure while extending it by 2.5m to ensure economical, environmentally less damaging and consistency with the neighboring property. Additionally, a letter of no objection has been obtained from the adjacent property at 11 Berwick Avenue, confirming agreement in principle. This proposal has been carefully considered to ensure it remains in keeping with the surrounding properties and complies with relevant planning policies.

Details of the pre-application advice received

A POSITIVE RESPONSE WAS RECEIVED WITH SOME OBSERVATIONS - The Planning Officer reviewed two proposed options for a 6m rear extension. Of the two, the option involving the extension of the existing rear addition is considered more likely to succeed. However, careful consideration must be given to the potential amenity impacts on the neighbouring unextended property at No. 11. These impacts include concerns related to bulk, massing, overdominance, and potential loss of sunlight, daylight, and overshadowing.

It was acknowledged that a side wall to the existing conservatory appears to be lawful. The officer also noted that a significant number of large extensions exist in the local area, suggesting that the character of the neighbourhood is unlikely to be a major concern.
