The main issues raised by the planning officer related to the scale and design of the original proposal, including the depth and height of the single-storey rear extension, the ridge height of the two-storey side extension, the relationship between the rear dormer and the proposed roof form, and the height of the side dormer. The officer also noted potential amenity concerns for No. 22 Westholme Gardens, particularly in relation to overshadowing due to the north-facing rear gardens.

The officer recommended that the single-storey rear extension be reduced to better accord with Policy DMHD 1, that the two-storey side extension and side dormer be set down from the main ridge line to appear more subservient, and that the rear dormer be redesigned so that it does not conflict with the proposed roof form. The Council also advised that the proposed render and external materials should be clearly labelled and that some exposed brickwork should be retained to preserve visual interest and reflect the local Metroland character.
