Group PSG1. Remove two slender Lawson cypress trees and two slender hornbeam trees at the northern end of the group.

Group PSG 3. 1x Lawson cypress - remove. 1x Hazel, cut stems to 1m stumps.

For justification, refer to the written advice.

Please note: TPO consent has been granted for the removal of most trees within the vicinity; however, Lawson cypress and hazel were missed from the species list of trees to be removed. The existing TPO consent is for the removal of hornbeam, oak, aspen, holly and laurel as G3 of the application made by agents for the adjacent property, 7 Rogers Ruff, which is damaged by trees at 26 Linksway - LPA ref 35888/TRE/2022/53. This application is for the additional work considered to be necessary

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
