One of the conditions of our planning approval was to go down a few steps on our patio so as not to be able to overlook the neighbour's house. As part of the condition and also something we are doing, we are making fences on both sides of the garden higher as far as the patio is coming out which prevents any onlooking issues. On this basis, we request the planning office to reconsider the condition and allow us to come out onto the patio at the same level as our house level. This allows us to make some use of the storage under the patio without breaking our back whilst trying to store the garden tools etc and we will also not lose space stepping out into our patio by building additional steps which are taking substantial. With the higher inflation and the cost of material and labour having increased so substantially, it would make a massive difference to have the patio at the same level as the house otherwise we would have to spend a lot of money to build a patio that still does not run at the same level as the house.
