SFA lifts brought into service 28 May 2021 but not met 12 month timescale due to 1.LBH not able to secure LIPP funding until February 2022 to complete necessary highway works preventing car park from opening until complete. 2.Delays in LU contractor starting the design works to the car park. LU project team state that LBH Highways Dept. due to commence highways works 18/10/2022 (installation of drop kerb) & complete Feb. 2023 (installation of a road safety scheme). The expectation is that both sides work simultaneously so LU due to undertake the car park works from 07/09/2022 to 02/03/2023 & proposing to open the car park in May 2023.
