Why do you consider that a Lawful Development Certificate should be granted for this proposal?

This proposal is for changes Permitted under Class B No part of the proposed works would exceed the highest part of the existing roof. No proposed works would extend beyond the plane of the existing roof slope that fronts a highway. The cubic content of the resulting roof space would not exceed 50 cubic meters. The proposal does not include any balcony features nor does it include the installation, alteration or replacement of a chimney, flue, soil or vent pipe. The dwelling house is not on article 2(3) land. The proposed material to be used will be similar to that of the existing dwelling house. The existing eaves (other than the hip to gable conversions) are retained, and no enlargement is less than 200mm from the outside edge of the eaves. All side glazing is obscure glass to level 3, and should there be any opening section the distance from floor level to the bottom of opening section shall be no less than 1,7m. Permissions under Class C No skylight installed would protrude more than 0,15m beyond the plane of the original roof slope. No roof light would extend beyond the highest part of the existing roof height.
