T1 Alder - Crown reduction by half.

T8 Leaning Alder - Crown reduction by half.

T9 Sycamore - Crown reduction by half.

T10 Sycamore - Crown reduction by half.

T11 Willow trunk on deck - Fell.

T12 Sycamore - Die back and multi-stemmed - pollard at half size.

T15 Sycamore - Two stem leaning - pollard.

T17 Leaning Willow - Large twin-stem - cut to low trunks.

Trees are very large and imposing - set between the river and residential houses. Their lack of management over the years has allowed their size to become non viable in such close proximity to the houses. They are very oppressive causing much distress to their residents, therefore, larger reductions have been specified to try and mitigate the social problems these trees are causing.

We would kindly ask this project be reviewed urgently by the planning authority as stress and anxiety by the local community is extremely apparent through the communication channels we have been party to.

The tree work will greatly tidy up this outside space improving quality of life for the residents. And make the trees viable for years to come.

No photos on this occasion due to our risk assessment. The trees are challenging to photograph due to the limited space, river side location and over grown nature of the vegetation.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
