Details of the pre-application advice received

Following refusal of the previous application, a further meeting was held with the case officer to review the decision. During this meeting it was clarified that the approved development at No. 20 Cherry Grove was assessed without the neighbouring property at No. 22 being served by a rear-facing window to a habitable room. It was also discussed that the first-floor room at No. 26 Cherry Grove does not meet the criteria of a habitable room. The case officer advised that a resubmission should be made supported by a plan demonstrating the layout and size of this room and by reference to the approval at No. 20. This application has been prepared in accordance with that advice.

Pre-application advice confirmed that the proposed two-storey side and rear extension would be acceptable in principle, subject to design and amenity considerations. The outbuilding, originally shown with independent facilities, raised concern about possible residential use; it has been revised to remain ancillary. The pergola, initially flagged as a potential issue due to height and proximity to the boundary, has been retained but reduced in height to 2.4m and set back more than 2m from the boundary, thus falling within permitted development limits.
