e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Oak (T1) reduce crown by 3m to reduce excessive shading to no 8.
Oak (T1) remove deadwood, crossing and rubbing branches to provide maintenance to and reduction of possible uncontrolled falls of timber from the tree.
Oak (T2) remove 4m of existing branches on South east side of tree to remove legal nuisance and provide safety from uncontrolled falls of timber to people using garden and swimming pool in no 8 where it crosses the boundary between the applicant's property and number 9.
Oak (T2) remove deadwood, crossing and rubbing branches to provide maintenance to this tree.
Oak (T2) reduce crown by 4m to reduce excessive shading to number 8.
