Conclusion

The proposed rear extensions by reason of their depth, bulk and size would appear as over dominant and insubordinate to the main dwelling and would appear out of character within the surrounding area. The ground floor extension by reason of its depth would harm the neighbouring amenities of no.30 Oak Avenue by way of loss of light, overshadowing and have an overbearing impact.

There is scope for a double storey side extension. However, it must be set down from the main ridge and set back further from the front elevation. The proposed side facing windows must be similar in size and style to existing.
