It is my belief that if permission is granted for the development to which this application relates the biodiversity gain condition would not apply: the application scheme will not create any new floorspace as it is only proposing a minor alteration to the existing plant area on the roof of the building. The application scheme does not propose a change of use at the site, which will continue to operate as a Class E unit. The existing building will be retained. No extension to the existing building envelope is proposed. There is not 5m of linear habitat such as hedgerows on the site which is subject of this application and as such there would not be any biodiversity within the site to impact. The site does not contain any non-priority habitat, therefore the application meets the 25 sqm de minimis exemption.
