In accordance with the above regulations, where a proposed development consists of the installation, alteration or replacement of a mast within 3 kilometres of the perimeter of an aerodrome, the developer shall notify the Civil Aviation Authority, the Secretary of State for Defence or the aerodrome operator\*, as appropriate, before making an application to the local planning authority for a determination as to whether planning permission will be granted for the development.

The application site in question is located approximately 3.5 kilometres north of Heathrow Airport.

I give notice that Avison Young of Norfolk House, 7 Norfolk Street, Manchester M2 1DW on behalf of Mobile Network Broadband Limited will be applying to Hillingdon Borough Council, Civic Centre, High Street, Uxbridge, UB8 1UW under the above regulations for its determination as to the acceptability of the following works:

*The removal and replacement of 1No. Existing antenna with 1No. Upgraded antenna, the removal and replacement of 1No. BTS3900A cabinet with 2No. S-Airo cabinets, the installation of 1No. GPS unit affixed to a support pole and ancillary development thereto.*
