Tree Type - Approx 20x Leyland Cypress (Cupressus × leylandii)

Approx. Diameter at 1.5m - 0.4m

Approx. Height - 6m

Location - On boundary between 19 Uplands court and Frith wood nursing home

Service - Crown Reduction

Work Required - Reduce height by up to 3m to give a finishing height of approximately 3m, Prune/trim lateral growth on clients side and Frithwood road to form a compact hedgerow

Reason - To reduce encroachment over parking spaces and to reduce wind sail effect

Priority Code - ON

Tree number - T1

Tree type - Red oak (Quercus rubra)

Approx Height - 14m

Location - Within car park, right hand boundary

Service - Prune

Work required- Prune lower lateral protruding towards G1 by removing approximately 2m

Reason - To tidy shape of crown

Priority code - ON

Tree Number - G2

Tree Type - Lebanon and Plum

Approx. Diameter at 1.5m - 0.2m

Approx. Height - 8m

Approx. Crown Spread Diameter - 4m

Location - In carpark, front boundary

Service - Crown Reduction

Work Required - Reduce height by up to 1m and lateral spread on all sides by up to 0.5m, to finished crown dimensions of 7m height and 3m lateral spread

Reason - To reduce end weight of branches, reducing the likelihood of branch failure

Priority Code - ON

  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
