Conclusion

This application seeks advice regarding the redevelopment of existing detached bungalow house to provide a two and half storey detached 4/5 bed dwellinghouse with associated parking and external works.

However, the submitted plans show only floor plans without any elevations. The illustrative floor plans shows a large square floor plans on all levels. On the basis of the submitted plans, officers were unable to provide detailed advice related to the application proposal.

Given that the site is currently developed with an existing detached residential dwelling and located within a built-up, the proposed development is considered acceptable in principle.

However, it will be subject to further consideration to ensure that any future design will respect the character and appearance of the local area and ensure a satisfactory relationship with adjacent dwellings is achieved.
