Formerly, on site there were garages used for storage which have been demolished a few years ago and the spaces have been re-orientated and are now available as additional parking spaces for rent for the residents of Pembroke House and Neyland Court.

Historically, Pembroke House was provided with 20 parking spaces (1 per flat) and Neyland Court only benefited from 3 visitor spaces. These 8 spaces are now available for residents of Pembroke House and Neyland Court to rent, although there is no obligation that the occupants of either property have to rent these. These spaces are only available for rent for these properties and are not for any use by anyone off site, nor are the spaces advertised for use by anyone other than the onsite residents.
