- Bricks from the demolition of the pier to be re-used where possible to repair the existing wall.
- Lime mortar to be used.
- Neil to liaise with Historic England to advise if they had any pertinent information to add, specifications, etc.
- Imperial bricks to be used to match the existing historic bricks – clay in colour with lime mortar.
- No requirement for a planning approval, just Listed Building Consent.
