Thank you for your email. I do empathise with the situation you are faced with , however the responsibility lays with yourself as the applicant and your architect to ensure that the correct information submitted is correct. Permission was granted on the basis that the information submitted to us including the boundary of ownership, was correct and this is not the case. As discussed in our telephone call the plans submitted illustrate an extension to be built on land which you do not own and you have not served the appropriate notice prior to submitting the application. As such the permission is not valid and cannot be implemented.

You will need to submit a section 73 application to vary the approved documents. If you can have your architect issue the revised plans and the form directly to me I will have the application registered without the requirement for a further fee to be paid.
