T1 Oak right front of house

Goals:

- Reduce size of crown height and spread
- Improve light and air penetration through crown
- Maintain size and shape
- Reduce live, over-extended branches as needed, 1-2 metres length reduction, entire canopy
- Remove 10 percent of dead, live branches, entire canopy
- Reduce live, interfering, over-extended remove epicormic branches as needed, see annotated pictures

T2 Silver Birch left front of house

Reduce size of crown height and spread

- Improve light and air penetration through crown
- Maintain a more compact shape
- Reduce live, interfering, over-extended branches as needed, 2-2.5 metres length reduction, entire canopy
- Remove 10 percent of dead, live branches, entire canopy

T3 Magnolia rear of house

T4 Magnolia left rear of house

Goals:

- Reduce size of crown height and spread
- Reduce density
- Improve light and air penetration through crown
- Improve appearance
- Reduce all live, interfering, over-extended branches, 2-2.5 metres length reduction, entire canopy T3 tree
- Remove 10 percent of dead, live branches, entire canopy
- Reduce live, interfering, over-extended branches as needed, 0.5-1 metres length reduction, entire canopy T4 tree
- Selectively prune height and sides in to maintain a more compact shape to both T4

Light prune of T3 top and light prune on spread and a thin only

Species Location

T6 Laurel right side of property rear garden

Goals:

- Reduce crown height
- Reduce live branches as needed, 1-2 metres length reduction, canopy height

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
