Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Pruning and reduction to the maximum extent permitted to 2 mature Sycamore trees situated in the Poplars car park, which are causing ongoing and significant nuisance to neighboring properties and vehicles due to excessive sap, seed fall, and general debris. The sap deposits are regularly covering parked cars, damaging paintwork, and creating substantial cleaning and maintenance costs for residents. In addition, neighboring properties are being adversely affected by overhanging branches, staining and excessive shading. The issue has progressively worsened over time and is now having a direct impact on the reasonable enjoyment and maintenance of surrounding properties. The trees have grown to a size where routine seasonal shedding and sap production are excessive and beyond what would reasonably be accepted and expected in a residential setting.

We are therefore respectfully requesting approval for:

1. A substantial crown reduction of both Sycamore trees to the maximum extent considered acceptable under current arboricultural guidance and council policy
2. Removal of overhanging branches affecting neighboring properties and parking areas.
3. General maintenance pruning to reduce sap nuisance, debris fall, and encroachment.

We fully appreciate the importance of maintaining healthy trees and preserving the local environment, and any works undertaken would be carried out by a qualified and insured tree surgeon in accordance with BS3998 tree work recommendations and any conditions imposed by the council.

We would be grateful if an inspection could be arranged at your earliest convenience, as the issue is ongoing and causing increasing frustration amongst affected residents.

Please let me know if you require photographs, a site plan, or any additional information in support of this application.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
