Details of the pre-application advice received

With regards to the revisions to be M4(3) compliant, as discussed, this cannot be revised under the discharge of a compliance condition. The planner has discussed this with management and the revisions would need to be assessed under a non-material amendment application - provided the sheds are not taller or deeper than approved (as the additional width needed does not appear to have an impact on the neighbours) there are not any immediate concerns.

The hedge will need to remain as approved as this increased the private amenity space. We do not need to consult externally on a non-material amendment application and it is not required to go to Committee.
