So I am now applying to reduce this Oak tree to the level of the adjoining oaktree (Tree2 below) i.e. to the existing crown of tree 2. This is the advice I am given as the tree is suffering badly from multiple shocks (impervious material on my neighbour's property, bacterial wetwood & DPM) & the advice to reduce the tree drastically is to try & save its help it to survive.

OAKTREE 2 To reduce the eastward growing scaffold branch by 2.5m and the upper re-grown canopy by 2 m. In support of this application I am also attaching a report by Slane Lanigan (29/7/23) of Abbs Es Arborial Advice - recommended to me by Hilltopda Canine Tree Dept.
