REMOVE LOWEST LIMB (LEFTSIDE VIEW FROM MY HOUSE (ELESSELE) OVER NEIGHBOUR'S GARDEN (AT 40 ELGOOD AVENUE). GIVEN THAT THIS OAK IS WEAKENED BY THE LIGHTENING STRIKE, IT IS WISE TO LESSEN THE WEIGHT ON THIS ONE-SIDED TREE. PLUS REMOVE ANY DEAD WOOD.
- ② HORNBEAM THIN BY UPTO 15%^{ONLY} - DEPENDING ON WHAT IS AVAILABLE.

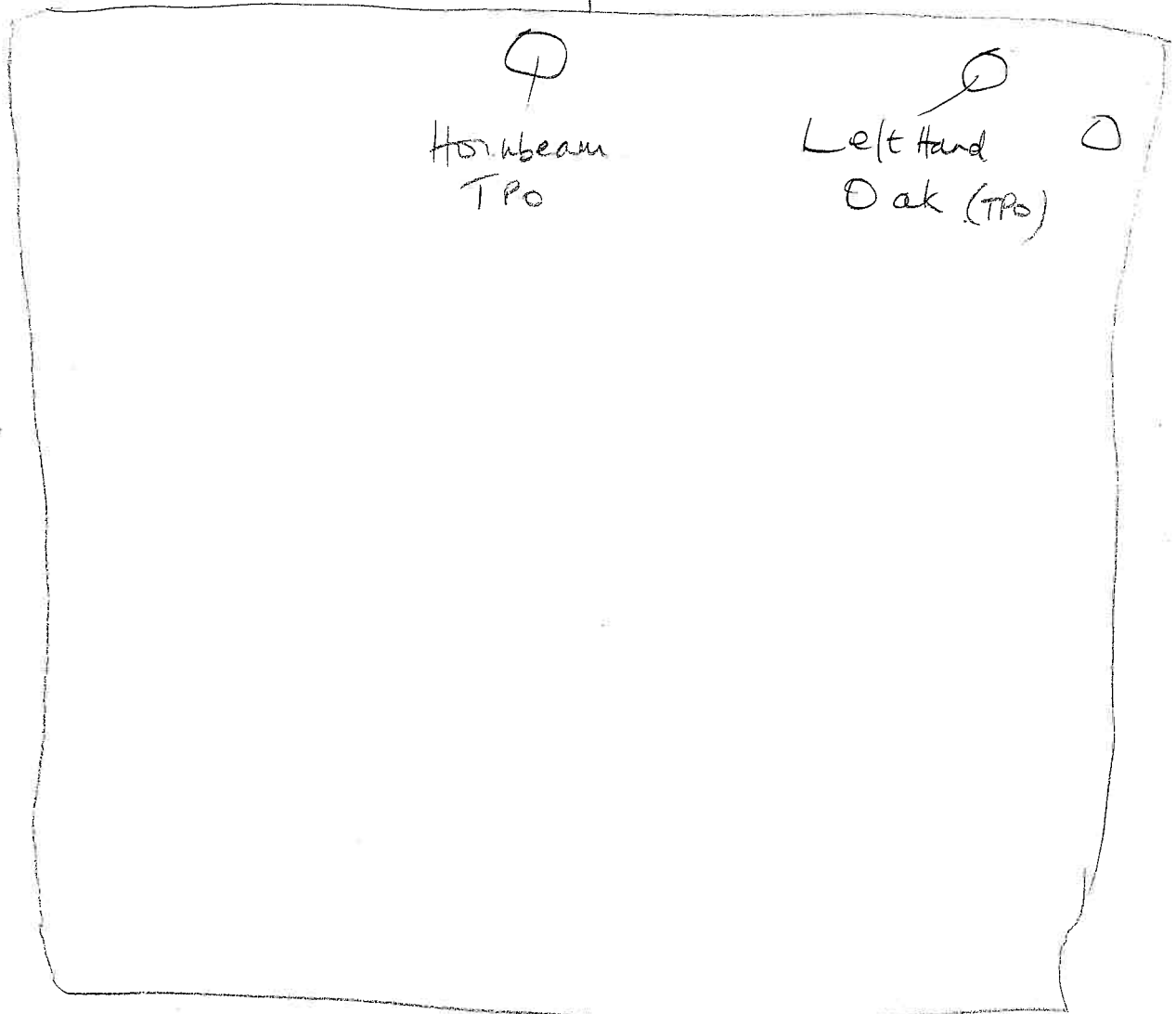
