1. Proposed Use Description

Northwood House is designed to provide short-term supported accommodation, lasting up to four months, for mothers and their babies. During their stay, mothers undergo assessments and receive tailored support to address any identified parenting concerns. The unit accommodates a maximum of two mothers and their babies at any given time, with a focus on fostering parenting skills in a stable and nurturing environment.

2. Justification for Change of Use

The proposed change of use is to create a small, specialized mother-and-baby unit that will accommodate only two mothers and their babies at any given time. This limited capacity ensures the unit remains comparable in size and function to a standard family home, with a total occupancy no larger than a typical family of four. Consequently, there will be no adverse impact on local amenities or parking resources, as the scale of activity aligns with the normal residential use of the property. Currently, there are no other facilities of this kind within the Hillingdon borough, highlighting a significant gap in support services for vulnerable mothers and their infants. Mother-and-baby units play a crucial role in providing a safe and supportive environment for mothers to develop parenting skills and receive tailored assistance during a critical period of their lives. The absence of such facilities in the area underscores the importance of this project in meeting a vital community need. Furthermore, the unit will operate in a way that integrates seamlessly into the neighbourhood, maintaining the residential character of the area. Its small scale and focused purpose ensure minimal disruption while providing a much-needed resource for the borough. This initiative not only addresses an essential social requirement but also reflects a thoughtful and sensitive approach to community integration.

3. Impact on Amenities

- The property includes sufficient off-street parking, which can accommodate up to 3 cars at any one time, minimizing any potential impact on local traffic and parking resources. The residents however due to their difficulties will not be driving whilst resident at the unit. The parking will be likely used by professional visitors and staff. The current parking available more than accommodates this demand. Photographs of the off-street parking are attached.
- In addition to this there is a local station (Northwood Metropolitan) and bus routes which are within reasonable walking distance, so will not be a necessary reliance on driving as means of commuting.
- Staff will not reside at the unit, however, will work shifts in 8-hour patterns, which means there will be 2 members of staff present at any one time. Shift pattern 8am – 4pm, 4pm – 11pm, Night shift.
- The property is a detached property with a public walkway running down the left side, which offers the property some seclusion. There are no plans to undertake any building works.
