T1 - Cedar - outside front of hotel

to remove one cedar tree as close to ground level as possible

We are seeking consent to remove this tree on the grounds of health and safety

as stated in the starling report attached this tree has been monitored since 2019 and it is known to be a roosting location for large numbers of starlings

the presence of these roosting birds is known to cause high risk of air line interference and can cause serious accidents resulting in catastrophic consequences

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
