### LONDON BOROUGH OF HOUNSLAW Road Traffic Regulation Act 1984 Section 14(1)

#### Temporary Parking Restrictions – Various Locations

- The London Borough of Hounslow hereby gives Notice that to facilitate highway works it intends to make an Order the effect of which would be to prohibit vehicles from waiting, loading and unloading in those lengths of road listed in Schedule 1.
- The Order would come into operation on 22nd July 2021 and would operate daily between the hours of 8 am and 4pm until 31 December 2021, to allow for unexpected delays and possible remedial works. The works are expected to be complete by 4pm on 19 August 2021.
- The above restriction shall only apply during such times and to such extent as indicated by prescribed traffic signs.
- Nothing in paragraph 1 of this Notice shall apply to:
  - any vehicle being used in connection with the said works;
  - anything done with the permission of or at the direction of a police constable in uniform; or
  - emergency service vehicles, subject to site conditions at the time of any emergency.
- Any vehicle waiting in contravention of any restriction imposed by this Order may be removed under the provisions of the Removal and Disposal of Vehicle Regulations 1986.

- Any vehicle waiting in contravention of any restriction imposed by this Order may be removed under the provisions of the Removal and Disposal of Vehicle Regulations 1986.
