- The purpose of the Order is to enable to carriageway resurfacing and safety improvement works to take place at A312 Church Road and The Parkway.
- The effect of the Order will be to prohibit any vehicle from
- (I) entering, exiting or proceeding in either directions on the service road fronting Nos. 406 to 500 Church Road between its junctions with the eastern and western arms of Langtry Road;

- (4) proceeding in a south easterly direction on the eastern arm of Willow Tree Lane between its junctions with A312 Willow Tree Roundabout and Glencoe Road, Residential access will be
- (5) proceeding in either direction on A312The Parkway between its junctions with Ossie Garvin Roundabout and White Hart Roundabout;
- (6) proceeding in a northerly direction on the northern arm of Glencoe Road between its junction with the eastern arm of Willow Tree Lane and a point 100 metres north of that junction. Local access will be

maintaineu.

The Order will be effective at certain times between 10th February 2014 and 30th April 2014 each day from 9:30 AM to 5.30 PM for article 3 (1) above only and between 10th February 2014 and 30th April 2014 every night from 9:30 PM to 5:30 AM for all articles above, or when the works have been completed, whichever is the sooner.

The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
