'Significant pressure' for ambulance crews

South Central warns of tough winter, with handover delays among concerns

South Central Ambulance Service is facing 'significant pressure' as it heads released last month, found a 71-yearinto the crucial winter period, its chief executive officer has warned, writes Sam Leech.

Problems at the service (SCAS), an NHS trust running ambulances in Berkshire and Buckinghamshire, see staff battle handover delays at hospitals and high numbers of 999 calls.

Board papers for the trust's November board meeting detail how pressures could put lives at risk during the cold winter months when demand for emergency care is expected to ramp

An update from SCAS CEO David Eltringham said: "The sustained high demand for our services is placing considerable pressure on the trust.

"Our frontline crews, call centre, PTS [patient transfer service], and support staff are all working hard and under significant pressure.'

One of the key issues identified is handover delays - the sometimes lengthy time it takes to transfer a patient from an ambulance to a hospital's emergency department.

Handover problems can lead to ambulances backing up in a queue outside emergency departments, which a SCAS risk report highlighted as a specific 'risk to patient safety'

The risk report said if the trust was unable to use ambulances efficiently this could mean delays in getting patients treatment – and be putting lives

A prevention of future deaths report old Berkshire woman died after waiting seven hours for an ambulance despite being identified as a high priority case.

The coroner concluded that issues with handover delays at Wexham Park Hospital in Slough and the Royal Berkshire Hospital in Reading had contributed to her death.

A separate Operational Winter Planning Report, also prepared for the trust's November meeting said:

'Service pressures including handover delays present a major risk if they continue at the current recent levels

To counter these issues, SCAS is introducing a maximum 45 minute handover time limit with the NHS trusts that run hospitals across its area of op-

This includes NHS Frimley Health Foundation Trust which runs Wexham Park Hospital and Ascot's Heatherwood Hospital.

SCAS is also working with Frimley Health and Care Integrated Care System (ICS) - a partnership of councils, community groups and NHS health trusts in Berkshire, Hampshire and Surrey.

In other measures to help cope with demand, SCAS has replaced and bought 53 new ambulances with a further 71 expected to have been delivered by March 2025.

It also makes use of private ambu-



lances to help plug gaps where NHS services alone cannot meet demand.

The winter planning report predicted more than 30,000 hours of ambulance staff working hours – including around 5,000 through private contractors - would be needed during December.

It expects this month to be the most demanding in terms of working hours.

SCAS ambulance crews could be further 'strained' if its resources need to

be shifted to other areas to cope with demand, the report added.

Mr Eltringham's board update said: We recognise the impact [pressure] is having on the wellbeing of our staff and the training of our student paramedics.

"We are committed to supporting our teams and are actively implementing initiatives to mitigate these pressures and ensure a sustainable working environment.'

Council still discovering 'skeletons', says finance lead

The council's finance lead said the Royal Borough is still discovering 'skeletons' left by the previous administration as the authority's £16million overspend was discussed on Wednesday, writes Anaka Nair.

Cabinet addressed a month seven budget monitoring report showing the expected overspend had ballooned to £16.181million – £5.7million worse off than two months before.

"From when we came in, we set to work to uncover all the skeletons left by the previous Conservative administration," said Cllr Lynne Jones, cabinet member for finance.

"We are still at the discovery stage in some areas, which needs to be completed before the organisation can really progress with recovery actions and fully implement any improvement or transformation.

"It is unfortunate that there has not been the will previously to undo the historical issues created and their impact."

Registered speaker Cllr Sally Coneron, the newly-elected Conservative councillor for Ascot and Sunninghill, said: "I am asking if you can rise to the serious challenges of today that the residents expect and stop hiding in the past.

"That's all I'm hearing is the past, the past, the past.

"In fact, to be honest, I really think it's time to call on you to resign and hand over the reins to those who are able to bring the chaos under control."

But Cllr Jones said not addressing issues is what 'got the council in this situation in the first place'.

"I would just like to draw people's minds to how that overspend has occurred," she said in response.

"We have a lack of systems, we have a lack of data, we have a lack of staff.

"We haven't been left the budget to put those back in place. We are having to do it and that is the overspend.

"Seventy-seven per cent of our budget is on social care so if we didn't have that budget those people would not have anywhere to go, they would not be protected.

"I am very sorry if you think our overspend is spent on things that don't matter.

"That overspend is absolutely neces-



sary to keep our residents safe and cared for."

Areas of deterioration outlined in the report are in adult social care and children's services, as well as temporary accommodation, parking and planning.

The number of households classified as homeless and requiring temporary accommodation is now 305, which is 'unprecedented' and assumes a rise to 350 households by year-end.

Planning costs and fees have deteriorated, including those from planning appeals while income is forecast to be below target due to a low volume of submitted plans.

Parking income is also looking 'increasingly unlikely to recover' to budgeted levels, despite being up by nine per cent on the previous year.

Around £1.97million has resulted from RBWM's work to rectify 'inappropriate' estimates on the lifespan of assets (asset lives) that were 'scored incorrectly' in the past.

Assets were being written off by up to 50 years when they would really only last a fraction of that time, the report said.

Write-off periods have now been shortened to show more realistic assumptions, but this is an additional £1.967million of charges above the budgeted £4.120million.

Addressing cabinet at York House on Wednesday, former Lib Dem councillor John Baldwin said incorrectly scored asset lives 'implies simple error'.

But the discrepancy between a 50-year write-off and assets only lasting 'a fraction of that time' painted a 'truer picture'.

"How can overstating assets lives so egregiously be anything other than a deliberate attempt to falsify and minimise MRP (minimum revenue provision) charges?" he added.

Mr Baldwin said 'bewailing its finan-

Mr Baldwin said 'bewailing its finan cial inheritance' and calling for an apology from the Conservative leader was 'no longer necessary'.

"You have several historical examples of clear malpractice," he said.

"You know the names of the officers who processed these entries. You know the names of the lead members with the relevant portfolio responsibility at a time these deceptions were [enacted]."

He asked whether the council had begun an inquiry 'beyond financial adjustments' and into liability, questioning whether there was an 'agreed strategy between elected members and the paid service'.

Council leader Simon Werner thanked Mr Baldwin and said they would take the comments on board.

Volunteers raise fears for community orchard

A Windsor community is fighting to protect a large community orchard – tended by volunteers over 'hundreds' of hours – under threat from the Sawyers Close redevelopment.

Plans are in motion to demolish and replace the existing eightstorey blocks of flats in Sawyers Close and replace them with nine new apartment buildings with 413 affordable homes.

Housing provider Abri and construction partner The Hill Group have said building is set to commence on site in early 2025, with the first new homes expected in 2026

A few years ago, a 'fantastic community orchard' of 19 trees was painstakingly put together by volunteers, co-funded by the council.

It is 'very rare' for its size and purpose – the idea was that everybody could enjoy the fruits of the volunteers' hard work.

The group that organised this, Green Earth Plan CIC, say that when the Sawyers redevelopment first came to light, they were 'assured and assured' by Abri that the entire orchard would be carefully relocated and incorporated into the new landscaping.

But the group is seeing 'no evidence' of this plan in action.

A few days ago, Martin Gibbons, who carefully watered the trees through their first two summers alongside his children, noticed they were in danger.

Hefty building materials had been placed right up against the young trees, threatening their survival – and a large construction vehicle had clearly driven 'right through' the orchard, he said.

"It's a miracle the trees weren't smashed down," said Martin. "There are huge tyre tracks. "The orchard hasn't been protected at all. Their assurances were hollow," he said.

That is despite the fact that large hoardings have been erected, protecting other parts of the area, he says – such as the new playground.

"We have spent hundreds and hundreds of laborious hours establishing this beautiful orchard," said Martin.

"A large number of people in the community planted these trees on a voluntary basis – no money – and watered them over two very hot summers to keep them alive.

"The construction industry sees these as just some little trees – an irrelevance – and doesn't place any value on them.

"But if you paid someone to [plant this orchard], it would cost thousands of pounds. It's a community effort worth thousands of pounds."

Martin is worried that there will be 'buck passing' and neither Abri nor any others will take responsibility to solve this.

"We feel let down," he said. "Urgent action is needed this week to protect these trees."

The volunteers want the trees to

be initially protected from any more such instructions – then they want to arrange for the trees to be moved within the next 12 weeks.

This is because this covers the winter dormant period where the trees do not grow, thus, the better time to transport them without harm coming to them.

After that, the orchard needs to be protected in its new location.

Residents and members of the Sawyers Close Windsor Facebook page also took to social media to register their shock and concern.

A spokesperson for Abri said, in response to concerns expressed online about trees being removed, these 'are not part of the community orchard and their removal has always been within the planning consent for the site'.

They reiterated assurances that the 19 trees in the orchard 'will be protected' and will be relocated to a new location within the site.

"We understand the building works may cause some disruption for our customers and neighbours, and we are working with our construction partner Hill to do everything possible to minimise this," the spokesperson said.



Jailed for drug offences

A man from Ealing has been jailed for 10 years for drug offences in Slough and Oxford.

Joseph Katende, 20, of Cotton Avenue in Ealing was handed the sentence following a hearing at Oxford Crown Court on Monday, November 18.

At the same court on May 13, Katende pleaded guilty to four counts of possession with intent to supply class A drugs, namely heroin and cocaine, and one count each of possession of cannabis, possession of a prohibited firearm and possession of ammunition without a firearms certificate.

The charges relate to incidents on July 21, 2023 in Slough and March 12 this year in Oxford where Katende was found to be in possession of drugs.

When Katende was

stopped in Oxford, he was also found in possession of a firearm.

Katende was arrested on March 12 and charged with all offences the following day.

Investigating officer Detective Sergeant Chris Bennett, said: "We will never tolerate drug dealing in our communities, which often harm the most vulnerable people.

"We will continue to proactively target and prosecute offenders, like Katende, and we will be visible and covert in our efforts to disrupt and pursue offenders who are involved in the supply of drugs.

"The information from the public around the drug supply offences plays an important role in developing intelligence into a proactive investigation."

First operator to be nationalised

South Western Railway is set to become the first train operator in the UK to be brought into public ownership under the new Labour government.

The operator, which runs trains from Windsor & Eton Riverside station to London Waterloo, will be steered by the Department for Transport from May 2025.

Two more rail operators are also set to be nationalised next year in a move the government claims will deliver £150 million in savings and drastically improve ser-

Department for Transport (DfT) secretary Heidi Alexander said: "For too long, the British public has had to put up with rail services that simply don't work.

"A complex system of private train operators has too often failed its users.

"Starting with journeys on South Western Railway, we're switching tracks by bringing services back under public control to create a reliable rail network that puts customers

"Our broken railways are finally on the fast track to repairing and rebuilding a

system that the British public can trust and be proud of again."

A spokesperson for South Western Railway said: "SWR already works incredibly closely with colleagues in the DfT and Network Rail to deliver for our customers and we're looking forward to developing that joined up approach even further in the future."

SWR also operates trains from Ascot and Sunningdale stations in the Royal Borough of Windsor and Maidenhead. It is operated as a joint venture between First Group and MTR Corporation - the latter also running Elizabeth line services till its contract expires next

There had been a call from trade union bosses to nationalise this line too, but Transport for London (TfL) opted to run with a private

company. When First Group and MTR's contract for SWR expires, services will be taken over by DfT Operated Limited – formerly known as DfT Operator of Last Resort Holdings Limited.

London and Essex train operator c2c is expected to join the public ownership portfolio in July, with Greater Anglia on board in

DfT said nationalisation will come into effect during a 'phased approach', with all contracts it will run finalised over the next three

DfT Operated Limited is anticipated to become part of Great British Railways - a future state-owned train company which the government plans to oversee UK rail operations.

The move comes after the government passed the Passenger Railway Services (Public Ownership) Act 2024, which it said 'paves the way for a shake-up of Britain's railways.

Railway Industry Associ-ation (RIA) Chief Executive, Darren Caplan, said the announcement was 'an important milestone on the journey to a restructured railway.

RIA has more than 400 businesses as members and lobbies government for railway improvements that it says would benefit the economy.

He added: "The UK supply chain will work with and support the government's plans to deliver improved rail performance and reliability, as we together develop world-class rail, both track

MP still hopeful over Heathrow rail link

Slough MP Tan Dhesi is leading calls to resurrect the long-awaited Western Rail Link to Heathrow project.

Network Rail's plans for a 6.5km rail link, connecting the Great Western Main Line and Heathrow Airport, have stalled since the coronavirus pandemic.

The proposed rail connection was meant to leave the Main Line between Langley and Iver before linking with Heathrow Terminal 5 via a new 5km tunnel.

This would provide a quicker option for passengers travelling to Heathrow from the South West, South Wales and West Midlands.

The current options for these passengers are either to travel into London Paddington to catch a Heathrow Express train or change at Hayes and Harlington to pick up an Eliza-

beth line service to the airport. terest - whether that's from

Slough's Labour MP told the Express: "This is the number one infrastructure priority for the region because it would have a transformational effect for businesses, for work and decongesting our roads.

'When you compare it to things like HS2 or Northern Powerhouse Rail it's dwarfed because it's less than one-anda-half billion pounds.

But for our area, not just Slough but the Thames Valley, this would mean 20 per cent of the UK's population would be within one interchange of our country's main airport.

The estimated cost of the project is £1.3billion but Mr Dhesi said significant funding from the private sector will be required to get the scheme up and running.

He added: "The Government

are saying we want the private sector to raise hundreds of millions of pounds and then we will commit to it.

"We've got to get that in-

businesses on the SEGRO trading estate, in Reading or perhaps even a sovereign wealth fund.

"A lot of the sovereign wealth funds from around the globe invest in certain infrastructure projects if they can get a return as well

'There's lots of different ways they can gain benefit but they've got to feel they can get that return.

Network Rail's plans for the Western Rail Link to Heathrow project were originally expected to be submitted to the Department for Transport in 2020.

But progress stalled upon the arrival of the coronavirus pandemic which led to a huge decline in passenger numbers and an impasse over Heathrow's third runway plans.

A spokesperson for Network Rail said: "The Western Rail Link to Heathrow project is not currently active.



"For administrative reasons it is marked as 'closed'. however it could be reopened again and become active if a satisfactory business case and funding agreement, including an appropriate contribution from the Heathrow aviation industry, is confirmed and progress is resumed towards submitting a development consent driving to Heathrow.'

order application."

A Heathrow spokesperson said:"Increasing use of public transport will help reduce emissions and congestion on local roads.

"We continue to explore how we can support new projects, including Western Rail, to reduce the number of cars

Humanitarian charity Khalsa Aid says rising intolerance is the biggest challenge for aid workers as it reflects on its 25-year history

Ravinder 'Ravi' Singh Sidhu founded the Sloughbased NGO in April 1999. during the Kosovo War. when a small group drove two trucks to the Albanian border for its first emergency provision.

Since then, Khalsa Aid has become an internationally supported charity with tens of thousands of volunteers across several global chapters including Canada, Australia, India and the

"We haven't looked back it's been a journey," CEO Ravi told the Express.

He described starting the charity as a 'massive' leap of

"We've covered almost every disaster and war in the last 25 years and we're always proud to say we started from Slough.'

Since founding the charity at age 29, Ravi said the 'passion' and ethos - to recognise the whole human race as one – remains the same

on its 25th anniversary.
"A lot of people think we only help Sikhs but we're anything but," said Ravi.

"I can't believe as a founder, how far we've got, where we ended up and how we ended up here. It's been amazing.

Ravi moved to Chalvey from Punjab, India in 1981, and set up the organisation's offices in Whitby Road in

That year, a reporter asked him whether the organisation would grow like The Red Cross, and Ravi was convinced it would.

"I said yes, we will. We became the first-ever Sikh humanitarian organisation - it was something I believed would grow," he said.

Ravi reflected on the generosity of local gurdwaras during the miners' strike whilst growing up in Slough during the eighties.

"In our faith, there is the saying 'Sarbat da Bhalla' or the wellbeing of all, so we are a very generous community – we don't mind who comes to the gurdwara," he

"We don't mind anyone eating with us in the langar hall. It's open to anybody. That instilled in me that our faith has shown us the path, why don't we do something for those who need it more?

'Now we're spending millions [globally], and it's all from the Sikh community. We don't get any grants or funding. Our community is very generous and that makes me very proud.'

The 'immense' paperwork has posed an unexpected challenge since expanding operations, but the charity which currently operates out of an office in Taplow hopes to relocate its headquarters back to Slough.

'Slough is where we started so it will always be our spiritual home," said Ravi, who says the charity is part of the town's 'fabric'

'From the Middle East to Asia, there's so much love for Khalsa Aid across the world. We try to live up to our name [and] deliver as fast as we can in an emer-

Ravi believes today's challenges are 'more difficult' than 25 years ago due to social media and rising intoler-

He also said there is more refugees' since the war in Syria began in 2011.

'We judge people without knowing their plight. Instead of jumping to conclusions, we need to be more understanding of their situation rather than their identity." he added.

Ravi said 'identity' has

been both a positive and a challenge to Khalsa Aid as an organisation too.

"Our identity is very distinct - the turbans, the beards," he said.

"People perceive you to be a religious missionary organisation. We're not.

"We don't even talk about who we are – we get stuck

He added: "Being a faith organisation, especially Sikhs, where the identity is big for us, the spiritual side gives us strength, and the physical appearance has become such a great symbol of hope in many places.

We stand out for a reason – that is our image – so people can approach us for any help.

"Khalsa Aid has become synonymous with Sikhism and that identity is very positive for us."

Speaking about the challenges of providing aid to Gaza, Ravi said the situation has 'deteriorated'

"You start out thinking everything is easy - you just take the aid - and then you realise the complexities of delivering aid in different border areas," he added.

"It's sad – politics is stopping a lot of the aid. It makes it difficult for us who are deeply passion-driven.'

"We're still learning some 'fatigue' and 'hatred towards of the ropes but it's all about compassion.


"It's amazing how [volunteers] kept my faith alive in humanity. Without our community's generosity, we couldn't do anything.

"Here we can call 500 people within 24 hours if we need, maybe more. There's so much support.'

The owners of a controversial town centre block of flats built without planning permission are fighting a council order to demolish it.

Slough Borough Council demanded last month that the half-constructed building in Wexham Road, opposite the Royal Mail office be demolished

But the owners have appealed to the Planning Inspectorate to have the order overturned.

Slough Borough Council told the Local Democracy Reporting Scheme (LDRS) it is confident the appeal will

A spokesperson said: "The council is very confident that it is able to defend its decision, both in terms of the enforcement notice and refusal of the planning ap-

The appeal comes after a year of twists and turns over whether the flats, which at six storeys high tower over neighbouring houses, should be allowed to be built.

Councillors on Slough's planning committee initially gave approval to the towering 27-home development in July last year.

The vote meant formal planning permission would be granted once all necessary legal agreements were signed.

That was against the advice of the council's own planning officers, who said it would create 'an overwhelming sense of enclosure and overlooking' towards neighbouring houses.

Conservative councillor Adil Iftakhar - who was chairman of the planning committee at the time - dismissed officers' objections as 'outdated' and a 'generic reason for refusal'.

He voted to approve the extension along with other Conservative councillors Nadeem Khawar, Gurchuran Manku and Zafar Satti.

Only three others voted against - Labour councillors Martin Carter, Harjinder Gahir and Pavitar Kaur Mann. Liberal Democrat councillor Asim Naveed abstained.

Yet formal planning permission wasn't granted as Wexham Construction Ltd failed to sign an agreement to contribute to the costs of new infrastructure to support the development within a six month time frame.

Such agreements are a normal part of the planning process and have to be signed for formal permission to be granted.

With the deadline passed. planning officers brought the application back to the planning committee in May this year - again recommending that it be refused.

By that time, all the councillors who previously voted to approve it had been replaced on the committee. This time the committee voted to reject the application - meaning it never had planning permission.

But by this point construction work was already underway. In the enforcement notice the council says the building should either be demolished or made to fit with plans for a smaller block of flats of up to four storeys that was granted planning permission in 2022

The notice was due to come into force on November 7, but Wexham Construction lodged an appeal against it. The firm's director, solicitor Ramandeep Purewall also lodged an appeal, as did Gian Purewall. Amrita Purewall and Mandeep Ajula.

That means a Government planning inspector will have the final say after a hearing set to take place next year.

The LDRS attempted to contact Ramandeep Purewall at the Harrow-based solicitors firm Aston Brooke where he is also a director, but received no response.

Coroner calls for 4G coverage on Elizabeth line **NHS** trust action

A coroner has said action must be taken to prevent future deaths in the wake of the suicide of a 36-year-old GP from Burnham.

Dr Jaipreet Panesar died in April 2023 after about a year of attempts to get help.

She had sought support from and been referred to multiple mental health teams during that time.

In an inquest last month, the sad circumstances of Jai's life leading up to her death were detailed by her family and various health professionals.

She had been suffering greatly after an unsuccessful jaw surgery that left her in chronic pain, alongside the breakdown of her marriage and other unfortunate personal matters.

Jai was said to have started pulling away from her family, who at times did not know her whereabouts and became increasingly worried.

Attempts to help Jai by her fellow GPs were frustrated by 'cracks in the system', the inquest found.

In particular, there were communications and recordkeeping problems which remain to this day - and must be addressed, the coroner

Heidi Connor, senior coroner for Berkshire, mapped the timeline of the most significant events leading up to Jai's passing in a Prevention of Future Deaths report:

June 21, 2022: Jai referred herself to the Crisis Response and Home Treatment Team (known as 'the crisis team'). She attended three appointments in June and

July 29, 2022: Jai was discharged from the crisis team to Buckinghamshire Talking Therapies (BTT). Whilst under this team, Jai disclosed that she had made previous suicide attempts.

August 2022 onwards: The mental health support that Jai received was from teams other than BTT.

These teams used a different electronic records system, Rio.

Despite being part of the same NHS body (Oxford Health NHS Foundation Trust), it was not possible

for clinicians to access both

August 31, 2022: There was an attempt to refer Jai to the crisis team again by her GP. After this, she was given an appointment with the community mental

health team for September 8. Jai attended A&E after being encouraged to do so by friends and her GP.

She was admitted as a voluntary inpatient to a psychiatric ward.

September 7, 2022: Jai was discharged from this ward and was under the care of the crisis team for around 10

After that no medium- or long-term plan was put in place and she was discharged back to the care of

April 27, 2023: Jai was found deceased in a hotel in Maidenhead.

At the time of her death, Jai was not under secondary mental health services - ie, those that meet the needs of people with longer term or complex mental health con-

Mrs Connor highlighted two matters of concern. One, that Oxford NHS

found no care co-ordinator or key worker was provided to Jai after her discharge from hospital on September

The Trust's plan was to review this by June 2024. This has been pushed back to January 2025 – almost two years after Jai's death.

The second concern is that 'it is still not possible' for teams using Rio and the BTT systems to access each other's clinical notes.

This coroner's report is being sent to Oxford NHS Trust, with the note: "In my opinion action should be taken to prevent future deaths and I believe you have the power to take such action.'

The Trust has a duty to respond by January 20, 2025.

Its response must contain details of action taken or proposed, setting out the timetable for this - otherwise, the Trust must explain why it is not taking any ac-

A spokesperson for the Trust said it has received the report and will be responding directly to the

Plan to extend Islamic centre

A proposal to extend a mosque and Islamic education centre in Slough has been submitted to the council.

Manor Park Pavilion is currently home to the Uiala Foundation, and these plans are for two single-storey side extensions of the existing building.

The charity began its services at Manor Park Community Centre in 2011 before by members, making this relocating to its current venue in 2018.

It has leased the 1,040sqm site on Villers Road from the council for six years and recently extended it as a base for another 20 years.

In addition to daily prayers, some activities include an elderly lunch club, a ladie" coffee morning and health and fitness class, the Ujala Walk Group, a youth club, a weekend school. Quran classes and a ladies Tajweed class.

The charity has been 'extremely successful' in providing services and helping people 'integrate [into] English society, culture and education', the applicant added.

Furthermore, this centre has 'reduced the burden' on other community centres in Slough.

The applicant said in a statement: "The centre has become useful in helping and advising the Muslim youth in integrating with the British society as well as having respect for the laws of the land.

The original building was extended more than 15 years ago but has been 'outgrown' proposed extension 'vital for its continued use.

"One of our key aims of Ujala Foundation is to build bridges of peace and unity across our multicultural society," the applicant said.

"The proposal is for an Islamic Culture and Education Community Centre to provide Islamic education to Muslims and non-Muslims alike, as well as understanding about the Islamic religion.

The site lies within a commercial and residential area. and the scale of development matches those of a similar design in the retail units next to the site.

The site is also accessible as the applicant believes 99 per cent of visitors will walk as they are largely based in close proximity to the centre.

Car parking]has never been an issue', the applicant added with resident permit parking on neighbouring Wellesley Road and onehour free parking for guests.

During prayer times, the centre can expect approximately 30 to 40 people daily and between 20 and 30 attendees to programmes such as learning English language and culture.

Staff at the centre relay information and provide help to those who may encounter domestic, financial, housing or legal problems 'where language and culture may be a hindrance', says the applicant.

Noise-generating activities during construction will be identified sensitively with work proposed to take place between Monday and Friday from 8am until 6pm, and Saturday from 8.30am to 12pm.

Colnbrook: Width restriction also introduced in Poyle Road

Bus gate trial aims to cut HGV traffic

A northbound width restriction and bus gate are being trialled in Poyle Road to cut down on the number of HGVs passing through Colnbrook.

Slough Borough Council said over the past several years it has been receiving complaints about the speed and number of lorries passing through the residential area along Bath Road.

The local authority said this has been a particular issue between Poyle Road and Bath Road (Elbow Meadow) to the

It has now introduced a new experimental scheme which includes a northbound width restriction and bus gate in Poyle Road (south of Mathisen

Bus gates are short sections

of road restricted to public transport or other authorised vehicles.

This would be located to the side of the width restriction. allowing buses and cars to continue northbound – but not HGVs.

The scheme aims to:

- divert HGVs to roads more suitable for their needs
- reduce issues currently experienced in the layby south of Mathisen Way
- ensure bus routes and journey times are not im-
- improve road safety in the
- ensure businesses and their operations are not affected
- improve air quality and reduce congestion, carbon emissions, and noise pollution by minimising HGV movements through predominantly residential areas

New signs have been introduced and the southbound carriageway for Poyle Road will be unrestricted for all vehicles, including HGVS.

HGV traffic can enter the industrial estate via Bath Road and must exit via Horton

A public consultation opened this week and will run until June 30, 2025, for members of the public to give their views about the trial.

Back in 2016, a consultation was held on a similar bus gate scheme but it was not brought in after businesses raised concerns over longer journey times to Heathrow for freight vehicles.

Conservative councillor Paul Kelly, cabinet member for housing, highways, planning and transport, said: "Tackling this issue feeds back to several of our council policies, including our low emission



strategy and local transport

"We have implemented this experimental scheme after complaints about HGVs and other traffic issues.

"We always want to hear the views of residents, commuters, businesses and stakeholders.

"Please give your feedback over the next few months as you get a feel for how it is affecting you and traffic in the area. We can then measure the impact of the experimental scheme.'

The trial will be in place for no longer than 18 months.

You can respond to the consultation online, by email, by post, or by phone.

Members of the public can visit Observatory House, 25 Windsor Road, Slough, to view a larger copy of the plan or to pick up a leaflet about the consultation.

Further information is also available at Colnbrook Village Hall during its opening hours.

The council said all feedback collected during the trial period will be used to decide whether to make the experimental scheme permanent.



Council defends new parking restrictions

Planned parking restrictions set to be rolled out across Slough have been branded a 'money-making scheme for the they'd been 'ignored' council'.

But council leaders insist both the new restrictions and the income they'll bring in are necessary.

Baylis and Stoke ward councillor Fiza Matloob (Lab) called on Slough Borough Council to halt the borough-wide controlled parking zone (CPZ) rollout at a meeting on Thursday, November 29.

The Labour councillor said: "The CPZ and how it's being implemented currently is flawed.

"The way that it's being implemented is nothing more than a money-making scheme to squeeze our residents.

Councillor Matloob added that a consultation on restrictions already rolled out in his ward ended in a 'massive rejection' by residents.

More than 1,400 people had signed a petition against the plans, and 550 people objected but councillor Matloob said

He called on council leaders to 'show they truly represent the residents of Slough instead of trying to squeeze them for every penny they can get out of them'.

But Conservative council leader Dexter Smith said the rollout would be introduced gradually, as a series of pro-

He said they were needed to address areas where there are already parking problems, but also to avoid 'displacing' those problems elsewhere.

He said: "It envisages that there will be a displacement of that where some of the extra parking demand that there is moved to areas where there are less controls.

"These controls might include things like waiting time restrictions or residents parking permits."

Councillor Smith also insisted the planned new restrictions 'is not just a moneymaking scheme for the council'

But he did say the money they'd bring in would be essential to fund parking enforcement. He said if they were scrapped, the council would have to find 'alternative sav-

ings' elsewhere. He said: "That income generated from controlled parling zones is built into our budget.

"The income is not just a moneymaking scheme for the council.

'It is money that is necessary to pay for enforcement. If we simply halt or remove this policy then we won't be dealing with the parking problems that are manifest like airport parking in areas that are on public roads.



Slough Borough Council is rolling out controlled parking zones across the borough in a 'phased approach'

This involves consulting residents in each area on proposed restrictions.

Draft council spending plans suggest the controls could contribute to £100,000 in income next year.

Councillor Matloob proposed

that the rollout be halted until it could be made more 'transparent' and 'inclusive', and until alternatives had been investigated.

His proposal was rejected narrowly, with Conservatives, Liberal Democrats and independent Chandra Muvvala voting against while Labour and Independent Group councillors voted in favour.

Confidence in hiring grew in run up to Budget – but will trend continue?

The Recruitment & Employment Confederation's (REC) latest JobsOutlook shows building momentum – including notable strength in London, the bellwether of the UK labour market.

Savanta ComRes interviewed a sample of 504 UK employers involved in hiring between August 5 and October 22, 2024.

Employers' confidence on the path of the UK economy remains weak, but has steadily recovered through 2024, while firms themselves have been getting more confident in their own investment and hiring decisions.

The positive sentiment in October is a promising signal of a potential shift in the labour market.

But the big question now is whether the large payroll tax raid in the Budget takes the steam out of this trend.

Neil Carberry, REC Chief Executive, said: "The strong growth in employer confidence about hiring and investing in their own firms slowed a little as firms awaited a Budget they knew would be tough.

"The scale of the changes to Employers National Insurance – in particular the decision to increase the tax far more for lower earners – will be a headwind for hiring confidence from here on in.

"But the economy and the labour market are subject to far greater trends than government action, and the gentle recovery of employer views on the wider economy will be what ultimately drives demand in 2025. London appears to be leading the way on this.

"The big question now is not if firms will restructure their hiring plans post-Budget, but whether wider economic growth will make this an annoyance in a growing wider economy, or a headwind that firms struggle with in a tough economy. The Chancellor has balanced the books on the backs of businesses across the country, now she needs to deliver on support for growth.

"A key part of this will be ensuring further costs are not layered onto employers unnecessarily. Making sure the Employment Rights Bill maintains and enhances our flexible, diverse labour market – rather than loading firms with more costly process that does not help workers – is a key test.

"Confidence trends this year suggest the labour market will remain resilient, despite ongoing economic challenges in 2025.

"Businesses are adapting, embracing new ways of working and determined to succeed. They can boost their ability to compete in the labour market by engaging with specialist recruitment and talent businesses, who can also help jobseekers with more up-to-date advice and guidance."

Employers' confidence in making investment and hiring decisions fell by six percentage points this quarter (to net: +2) – down from the notable near-term peak of net: +16 in the three months to June 2024. But the quarterly fall was driven by a sharp decline in confidence in August (to net: -7), after which it recovered strongly through to net: +9 by October.

The +2 still shows employers getting more confident across the quarter.

The survey found that employers' confidence in the UK economy performance improved by one point (net: -25) when compared to the three months to August.

Looking at month to month, crucially

sentiments improved in October (net: -17), compared to September (net: -32). While this trend is still negative, it has been improving across the year.

Short-term permanent hiring intentions remained positive but fell three percentage points this quarter (compared to the three months to August), to net: +11.

But London remained a notable positive outlier, improving from net: +20 to net: +27 between the two periods.

Slough Town FC: Boss urges players and fans to make life 'as uncomfortable as possible' for Maidenhead

Scott Davies has said he wants Slough Town's players and supporters to make life as 'uncomfortable as possible' for Maidenhead United's players during Saturday's FA Trophy third round tie at Arbour Park.

But they've never gone there to take on the Rebels in a competitive fixture, and - barring a couple of county cup contests - the two teams haven't met in national competition or league match for more than two dec-

Slough come into the tie off the back of a disappointing 3-1 defeat at Chelmsford City, but Davies said he and the players had a drawn a line under that one and would approach this game with optimism and confidence.

Maidenhead meanwhile have won only two of their last 12 matches in all competitions – and were thrashed 6-2 away by National League leaders York City last Saturday. 'We've parked last week. I think you must. If you look at the season, we'd have snapped your hand off to be where we are. We're seven points off the top of the league, which is like dreamland for us. We're in amongst the pack, we're in a good position and

"But the cup takes you away from the league for a couple of weeks and it's a great game to have.

Anyone coming to our place knows they're going to be in for a game. And like I've said to people this week, we want to make Maidenhead feel as uncomfortable as possible out on the pitch and that's down to us, creating a tempo we can play at, and at home that's served us well."

Davies added that he thinks the Magpies have more to lose from this tie that the Rebels, adding that he wants his side to be 'fearless' in how they approach the game.

He added: "We've lost two games in 35. When you look at that it's incredible compared to what it was like before that. At our place, it's different to maybe having to go away to play at Maidenhead. I think we'll turn it into a game that suits us, and we've got the advantage of playing on the 3G every single week which they won't have.

"Every single percentage that we can use as an advantage, we'll try to use that and hopefully we can. But I also believe we have a good side. I know there's a difference between the two leagues, but we've got a team that are full of confidence, even coming off the back of a defeat last weekend.'

Davies also came back into the side alongside Hay to replace Dan Roth and Kwadwo Bugyei-Kei who missed out because of illness and injury.

Despite this, the visitors made a positive start, with Evans getting on the end of another superb assist from Slavi Spasov to give them the lead in the 34th minute. Again, it was Spasov's quick footwork and quick thinking

that created the chance, and Evans' great positioning to tap home from close range.

It's a forward partnership that's developing nicely for the Rebels but unfortunately, they weren't ahead for long. Chelmsford hit back before the break with a goal from Cameron

Slough defended deep in the early stages of the second half and looked to spring the counterattack through the likes of Abisogun and John Gilbert. But on this occasion, the Clarets were ready for them and the hosts took the game away from Slough with two goals in quick succession.

First, in the 65th minute, substitute

Kane Crichlow came on to make an immediate impact by finding the back of the net. He then extended Chelmsford's lead with another simple, clinical finish under Charlie Horlock to make it 3-1 in the 69th minute.

The Rebels had an excellent chance to get themselves back into the game when David Ogbonna cut the ball back for Spasov to strike at goal. But his effort crashed back off the crossbar and with it when the visitors' chances of getting something from the game.

Slough drop back to eighth in the table, a point outside the play-off places and seven off the leaders ahead of Saturday's FA Trophy tie at home to Maidenhead United.
