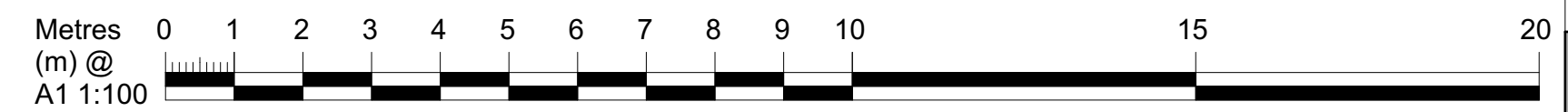
01 Proposed Elevation A-A

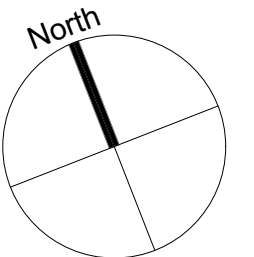


03 Proposed Elevation C-C
