Faith explained that AC units for the home were not under 'permitted development' as commonly believed and needed a planning application. The owner was not aware of this and distressed; Faith reassured her and advised that a retrospective planning application be prepared and submitted in a reasonable time (to allow for sourcing a suitable architect and drawings prepared). The owner was upset about timescales and Faith advised that an extension be sought as the owner expressed she would be keen to get an application in as soon as possible. Faith also provided a photo-shot to show that another property on the street had a similar external AC unit but was visible from the street.
