Dear Mr Lall,

After the site visit and discussion with my Team Leader, unfortunately we will be recommending the application for refusal due to the harm to the neighbouring properties side facing windows (no.19).

I have a possible solution for you and your client to explore:

You could withdraw this application and apply for a 4m deep rear extension with the same roof height and form under a prior approval application (extending beyond the house only, not the garage). If no adjoining neighbours object to the proposal and we grant permission for a 4m extension, you could re-apply for the 6m and garage conversion under a householder application with the 'free go route'.

Alternatively, we could approve this application with the garage conversion only.

Please let me know how you wish to proceed.
