Tree species: Hornbeam

Location: Rear garden

Proposed works: Crown reduction by up to 1-1.5m in height and lateral spread, ensuring a balanced and natural shape is maintained.

Removal of any deadwood within the crown.

Justification for works:

The Hornbeam tree has become excessively dense over the past three years, resulting in significant shading of the garden. The canopy currently spans the entire lawn and encroaches over approximately 25% of the patio, substantially reducing natural light to the garden and the rear of the property. The tree overhangs a garden shed, where persistent shading and moisture have led to moss accumulation and deterioration of the shed roof.

Additionally, during periods of high wind, particularly in winter, there has been frequent branch drop and deadwood falling onto the patio and roof area, presenting safety concerns for the occupants and potential property damage. The proposed crown reduction will help mitigate these risks, improve light penetration, and maintain the tree's long-term health and structure.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
