The proposed rear dormer would be acceptable in its current form.

The proposed side dormer would be visible from the public realm and street scene on Church Road and Pippins Close and would detract from the existing hipped roof form of the existing dwelling. The proposed side dormer is very similar in size, form and design as the previously refused application under reference 43769/APP/2021/3246. It is concluded that the proposed dormer would be a visually imposing feature, unsympathetic to the architectural features of the host building and the character of the wider area. The balance between the application site and the attached neighbouring dwelling would be disrupted, creating a bulky addition that would disrupt the rhythm between the two properties which appear in the street scene. It is considered that this would be contrary to Policies DMHD 1, DMHB 1, DMHB 4 and DMHB 11 of the Hillingdon Local Plan Part Two: Development Management Policies (2020). The proposed side dormer is not considered to have overcome the previous reason for refusal.

The proposed rooflight appears overly large and bulky on the front roof slope. If a rooflight was to be proposed, it is recommended that it is made smaller and be a conservation style flush rooflight that would not project further than the original roof slope. This would be subject to a full assessment within a formal application.
