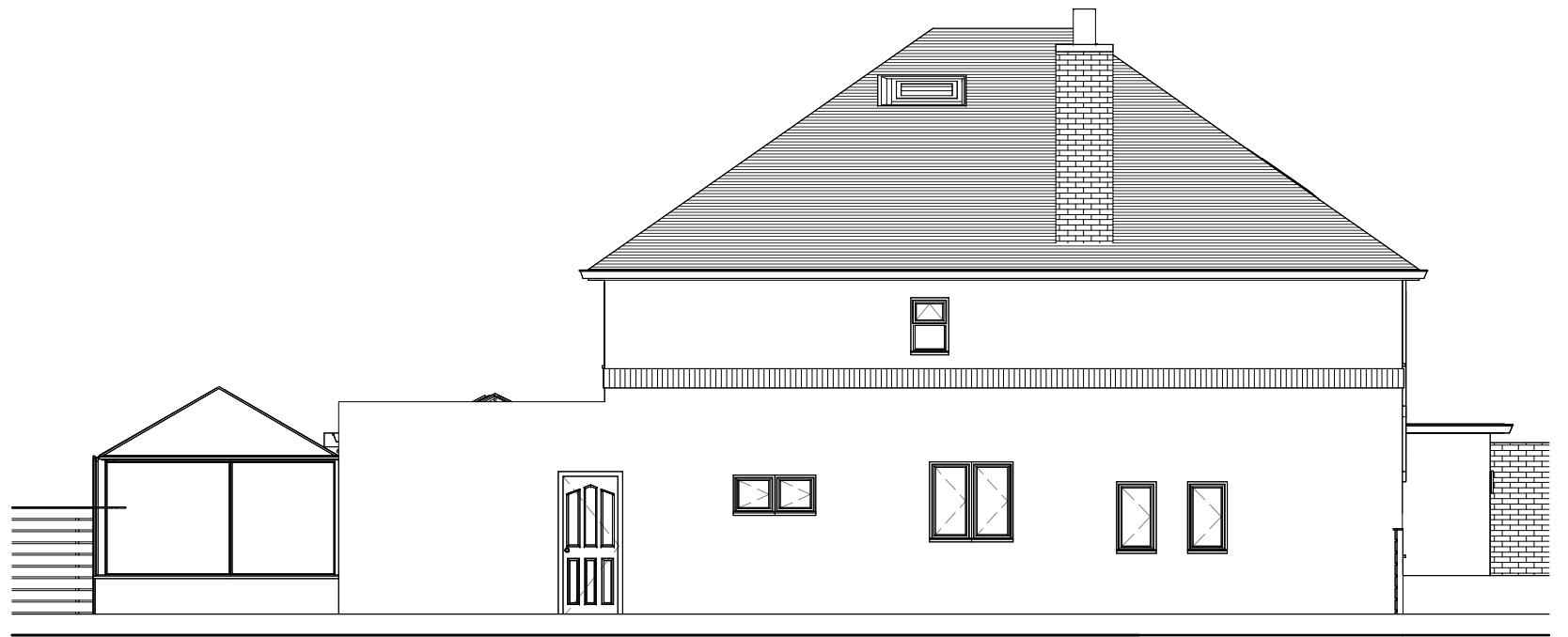
Proposed Side Elevation

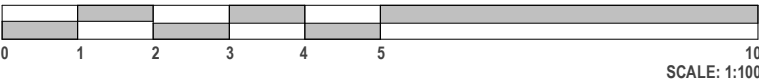
Proposed Rear Elevation

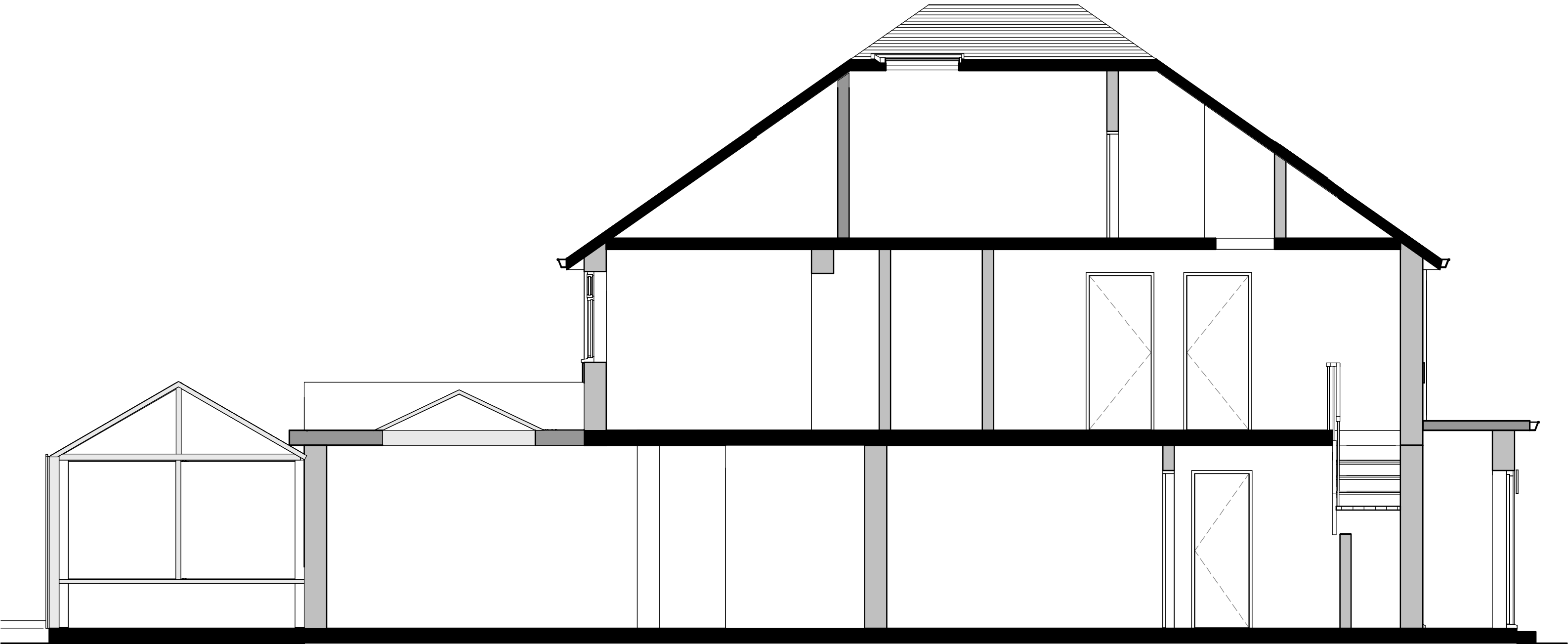

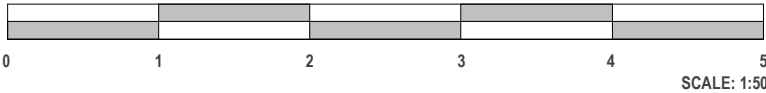
