Conclusion

Further evidence is required in order to demonstrate that Unit B, which would be demolished has been marketed for an industrial use for a minimum of 2 years, as the building has an existing industrial use and falls within a Strategic Industrial Location (SIL) and the loss of industrial space within SIL's has the potential to compromise the provision of an important supply of industrial land contrary to Policy DME 2 of the The Local Plan: Part 2 - Development Management Policies (2020) and Policy E5 of the London Plan. The acceptability of extending the building and community uses on the site is also subject to demonstrating that the expansion of the uses would not prejudice the existing and future operation of the adjoining industrial sites to the east, south and west.

Detail must be set out within a comprehensive management plan outlining how the extended centre will operate. This will need to include detail regarding hours of operation, activities and expected numbers of visitors - including when the number of visitors would be highest. A Transport Assessment and Draft Travel Plan would also be required which sets out existing patterns of travel, expected trip generation and modes of travel.

The simplified design option is favoured by officers, however if proceeding with the centre's preferred option, it would be expected that visual imagery is prepared to indicate how the building would sit within the context of the surrounding development given the prominence of the minaret as a taller feature.
