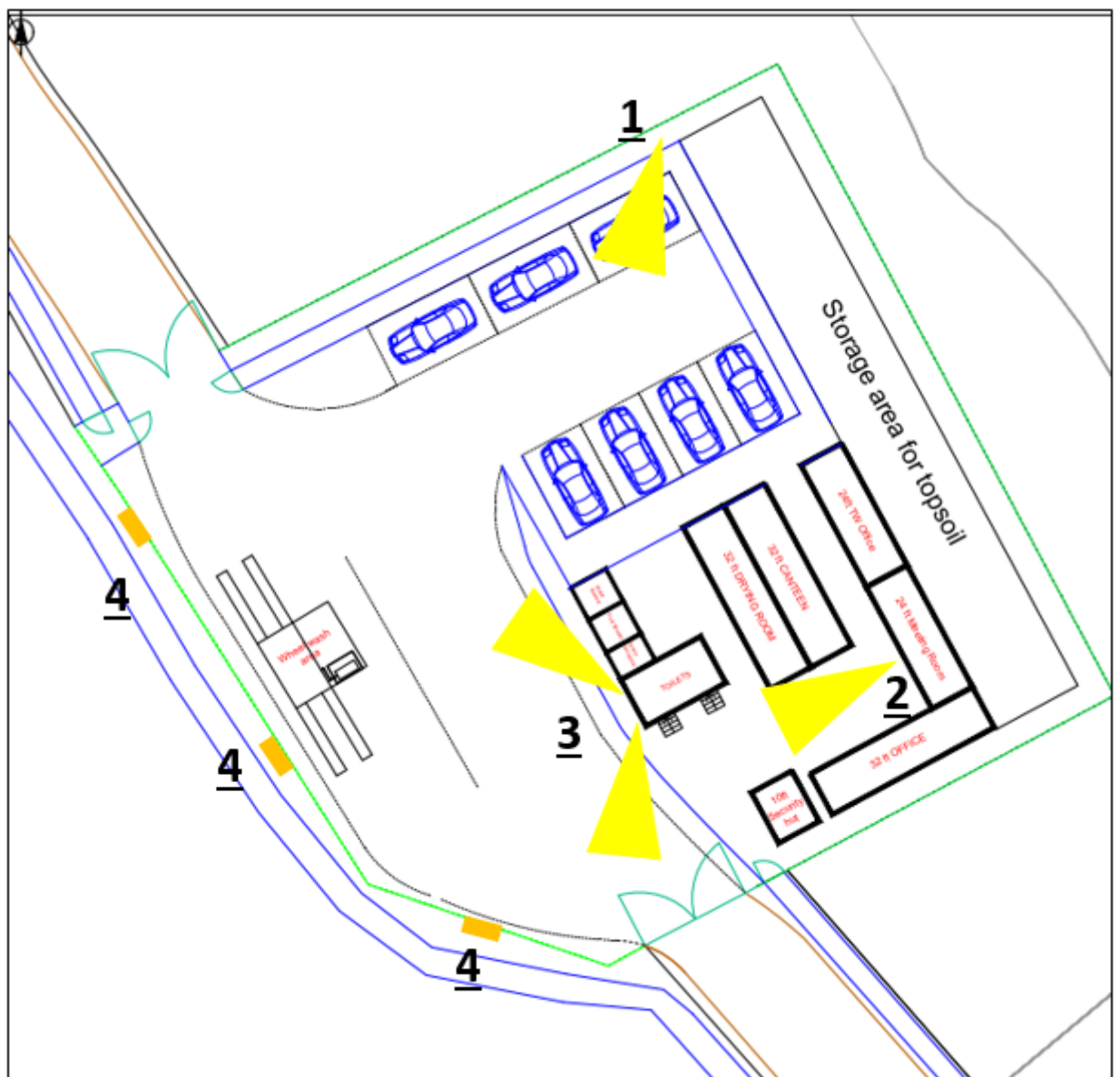
Hi Karl,
