Work required - Remove epicormic growth at the base of the tree up to the first crown break.

Reason - To reduce encroachment over driveway

Location - Front garden

Service - Crown lift

Work required- Lift crown to give around 2m ground clearance all round. Trim annual growth from Lawson Cypresses all round by removing up to 0.3m

Reason - To reduce encroachment over driveway

Priority code - ON

Tree Type - Leyland Cypress (*Cupressus × leylandii*)

Approx. Diameter at 1.5m - 0.3m

Approx. Height - 10m

Approx. Crown Spread Diameter - 4m

Location - Rear garden, back left corner

Service - Crown Reduction

Work Required - Reduce height by up to 5m and lateral spread on

Clients sides by up to 1m to finished crown dimensions of 5m height and 3m lateral spread

Reason - To reduce encroachment over lawn, to form a manageable hedge

Priority Code - ON

  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
