Re: Application for Removal of Protected Tree Under Tree Preservation Order

Dear Sir/Madam,

I am writing to formally request permission for the removal of a tree that is protected under a Tree Preservation Order (TPO) located at the front drive of 235a Long Lane. The tree in question, is an Oak Tree, is suffering from a severe disease and has developed significant deadwood, posing a serious risk to both property and human life.

Details of the Tree and Its Condition

Location: Please find attached PDF 'Location Plan' showing the exact location of the tree

Species: OAK

Current Condition:

The tree has been diagnosed with a disease, there is a substantial amount of deadwood present, as evidenced by the attached photographs. The disease has caused extensive decay, leading to a loss of structural integrity.

Reasons for Removal

Health and Safety Risks: The deterioration of the tree has made it structurally unsound, presenting an immediate danger to nearby structures, vehicles, and pedestrians. There are already branches that fell over and have caused extensive damage to the neighbouring car, and there is likelihood of a repeat episode especially during adverse weather conditions.

Impact on Property: The tree is located in close proximity to buildings (235, 235a & 237 long lane), vehicles, increasing the risk of damage. Falling branches or the tree itself could result in significant financial losses and potential injury.

Inability to Save the Tree: Given the advanced state of disease and decay, arboricultural verbal advice (Pinewood Tree) has indicated that removal is the only viable option. Attempts at treatment or pruning are unlikely to restore the tree to a safe condition.

Supporting Documentation

Photographs: Attached are recent photographs illustrating the extent of deadwood and disease affecting the tree.

Location Plan: A detailed location plan is attached, clearly marking the position of the tree within the property.

In light of the above reasons, I propose the following actions:

Removal of the Diseased Tree: Please grant permission to safely remove of the tree by a qualified arborist to eliminate the immediate risk posed by its condition.

Replacement Planting (if applicable): [Optional] I am willing to plant a replacement tree of a suitable species and in a suitable location, as advised by the local council, to maintain the environmental and aesthetic value of the area.

I understand the significance of the TPO and the importance of protecting trees within our community. However, the pressing safety concerns necessitate this application. I am committed to working with the council to ensure all necessary procedures are followed and to mitigate any negative impacts on the local environment.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
