Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Oak Tree T1 on TPO 315. There is just one tree in the garden at the address 5 Pine Trees Drive.
The tree has been neglected and not been pruned since 2019 and has become far too big for the size of the plot.
It now overhangs the garden of number 4 Pine Trees Drive by approximately 4 metres.
It creates excessive shading in both gardens and excessive dropping of material into next door garden at 4 Pine Trees Drive especially in a mast year.
There is a concern that it is a danger to properties in high winds.
Work: Reduce size by at least 3m radius 6m diameter all round to balance by cutting back to 25-50mm beyond previous reduction points.
Reduce height by crown reduction to previous pruning points.
Thin by removal of epicormic growth.
Reasons: Overdue maintenance, reduce shading and allow improved enjoyment of garden for number 5 Pine Trees Drive where the tree is located.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
