am attaching that exact planning permission and from what I can tell there were no conditions attached that take away permitted development rights for extensions or outbuildings.

I would, therefore, suggest the Lawful Development Certificate route for the rear dormer, which must be no more than 50 cubic metres in volume, no higher than the ridge (and up 20cms from the eaves), and be tile hung with ant side windows being obscure glazed. Class B on loft extensions in the attached document refers, in case I have forgotten any other criteria.
