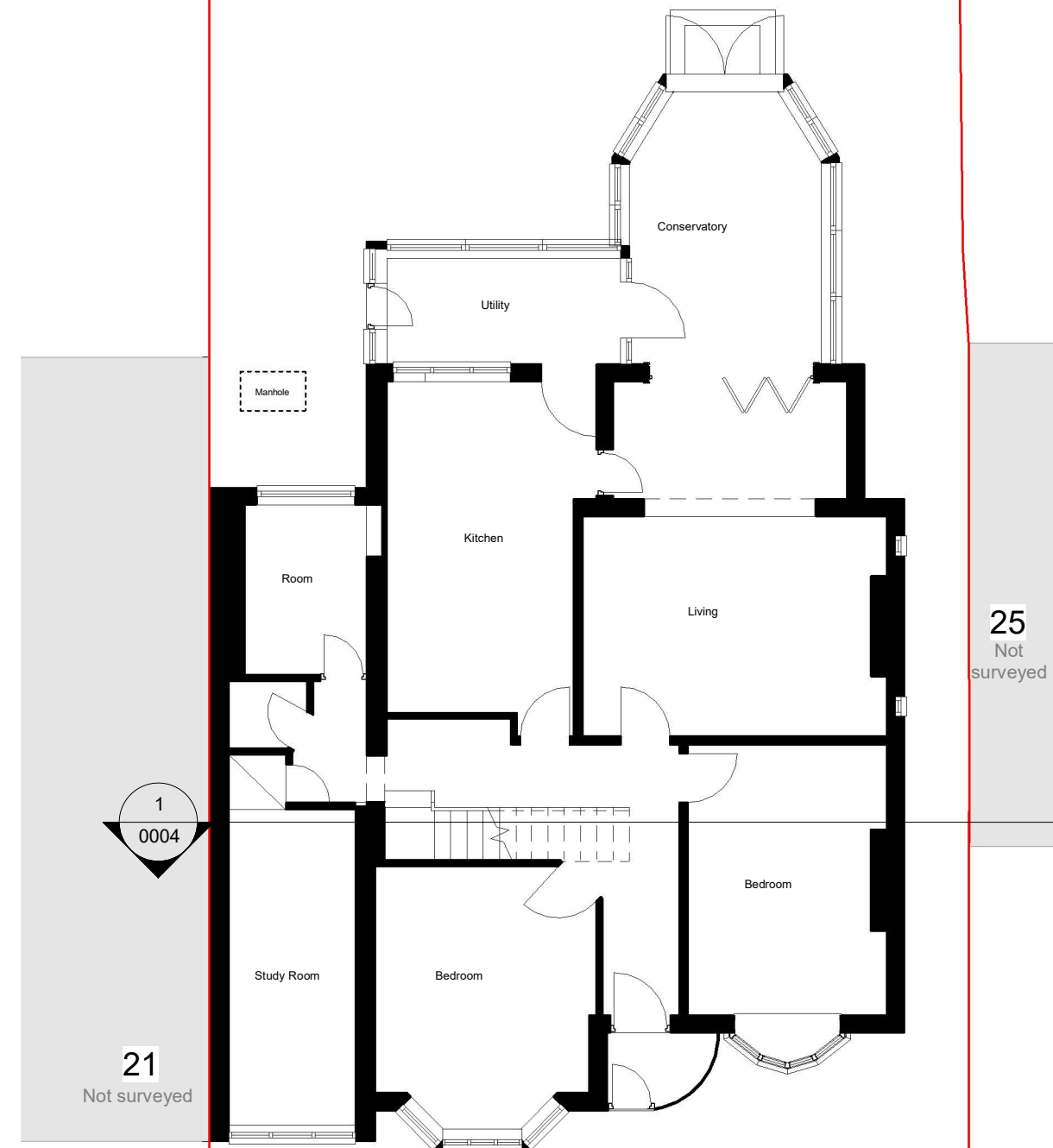
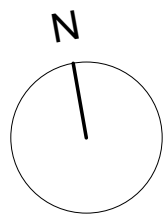


00-Existing Block Plan

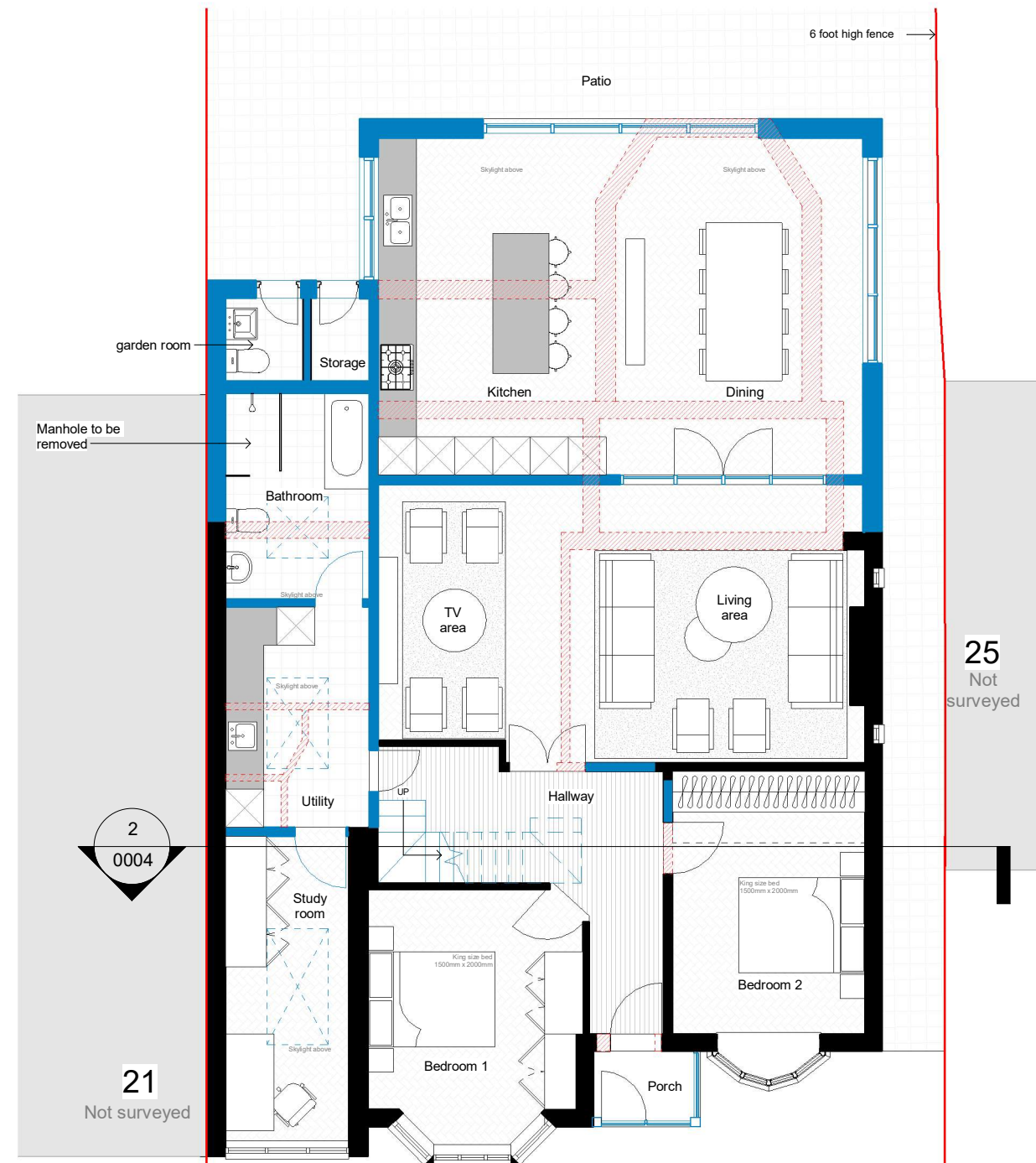
00-Proposed Block Plan

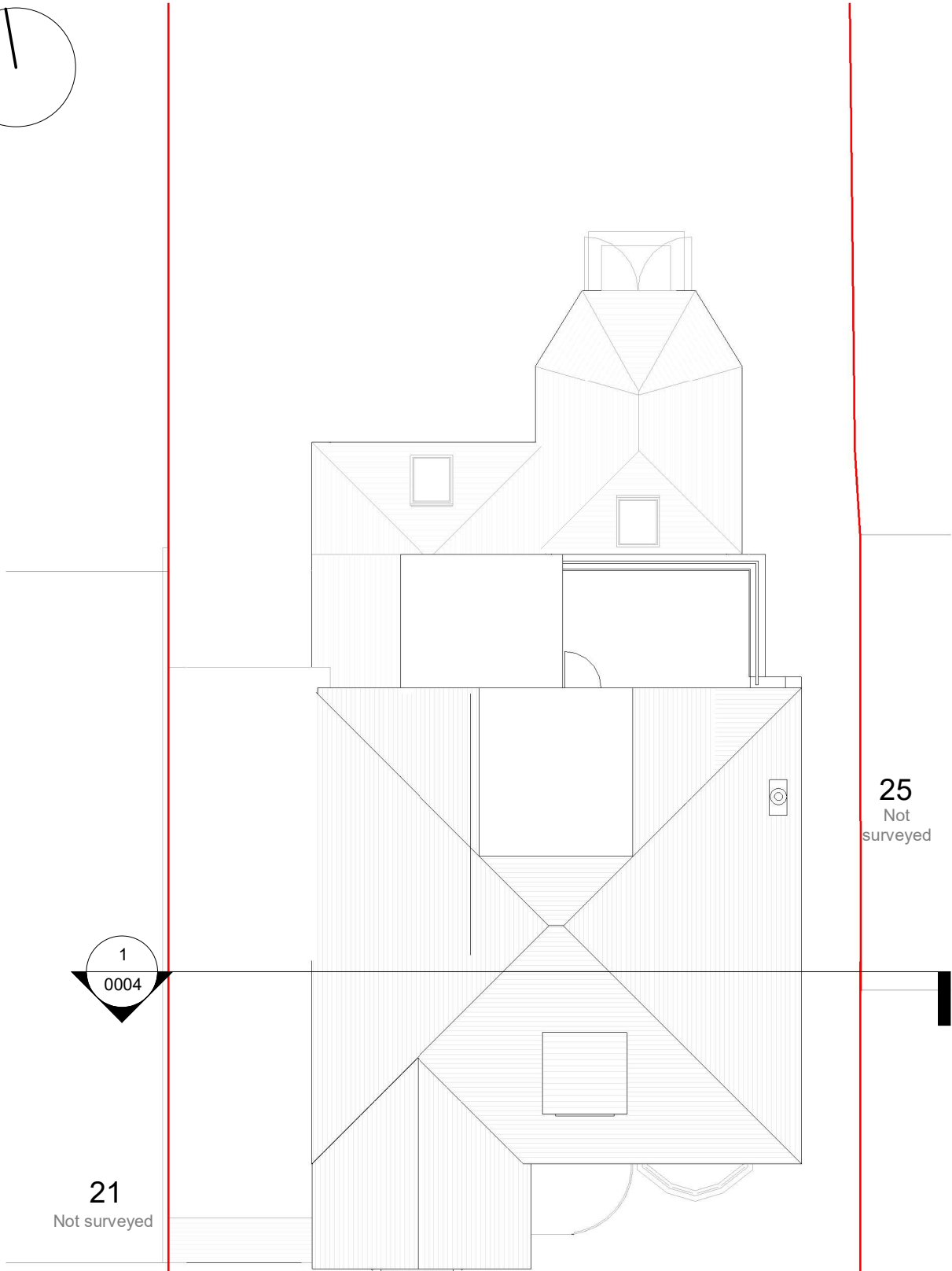
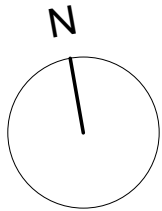


01-FF Existing

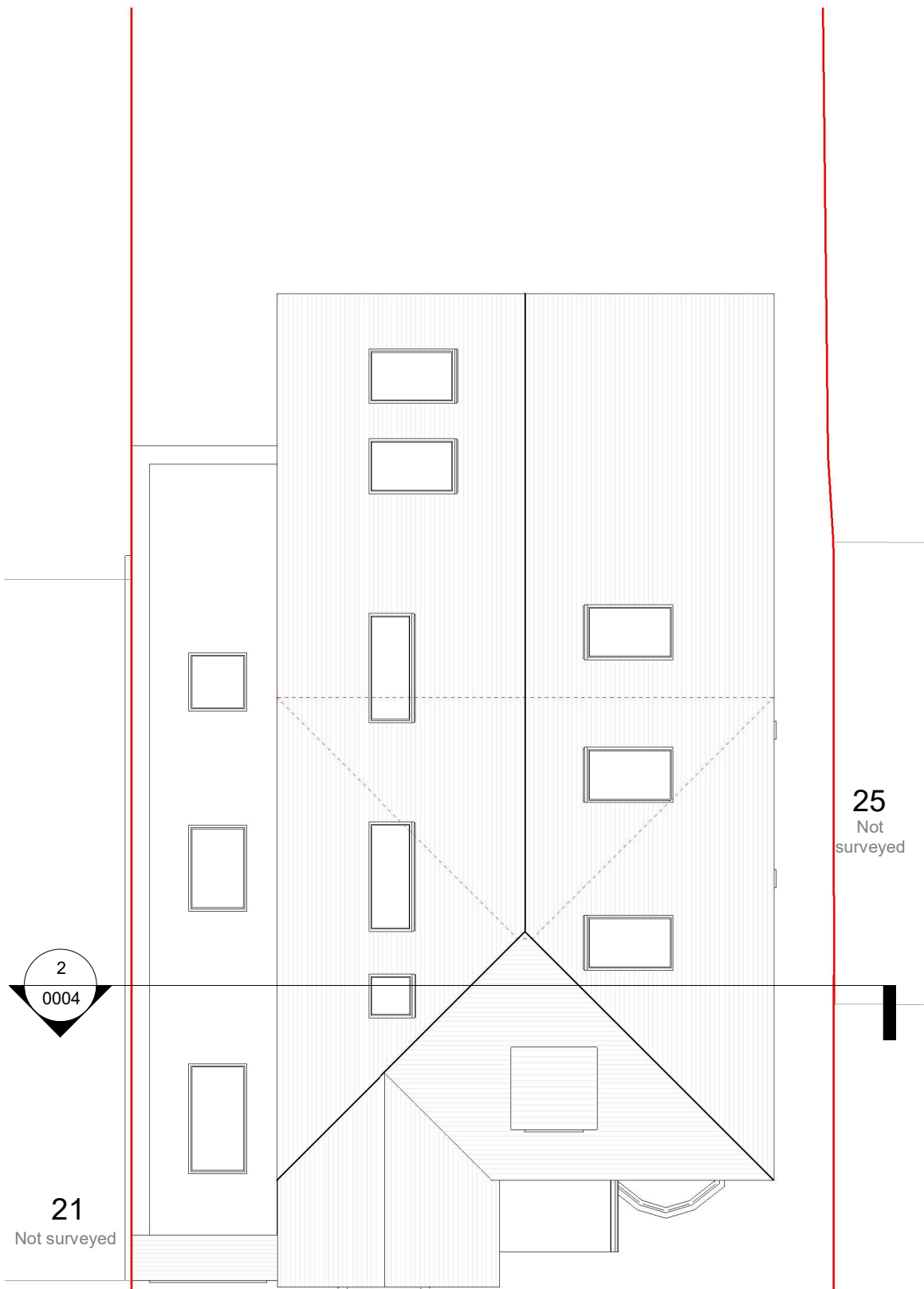


01-FF Proposed

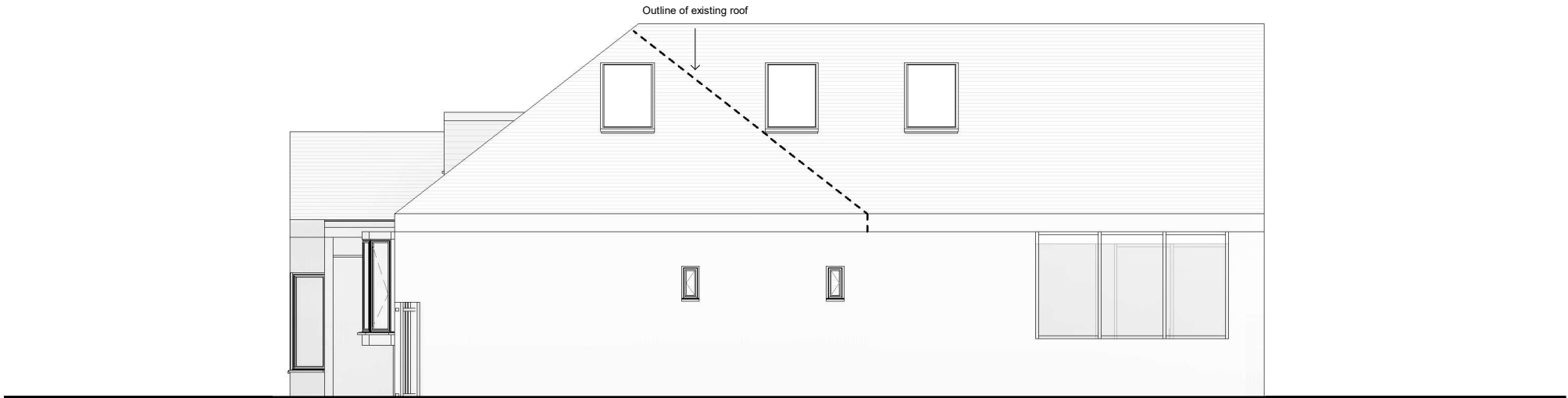

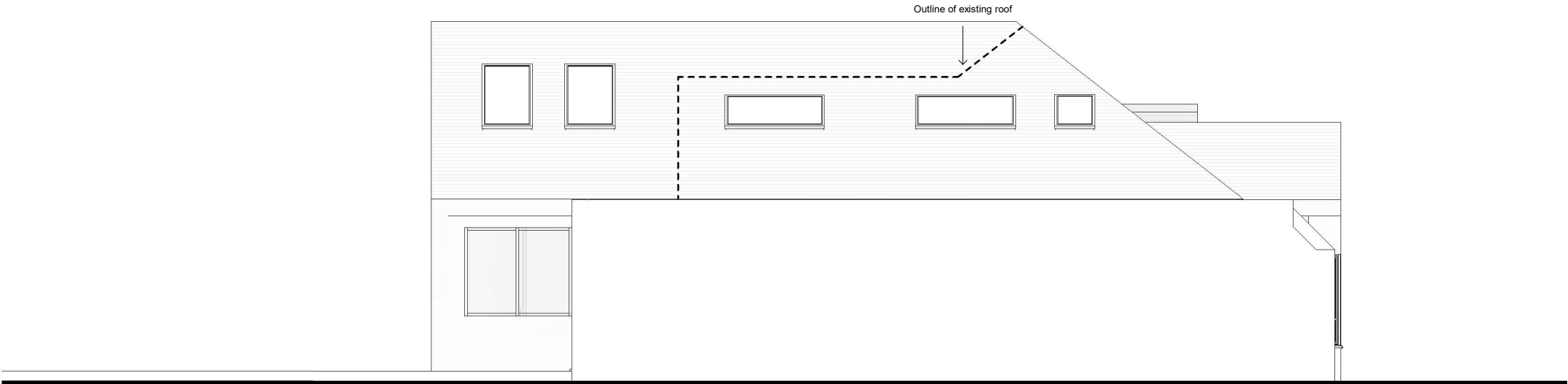
