Conclusion

There are concerns regarding the cumulative impact on the existing dwelling and the Area of Special Local Character. In its current form, the external changes to the front of the property and roof element to the rear would cause harm and would not be supported. . As such, it is considered to be incongruous and to cause serious visual harm to the street scene and wider area. Given the homogeneity of the area, the raising of the roof line and the proposed front elevation would not be in keeping with the street scene and would set an unwanted precedent of similar extensions in the area. As such, the proposal does not accord with Local policy.
