Details of the pre-application advice received

The planner Ms Smith visited the house and met with the applicant and architect on 3 April 2025. About three weeks later, on 25 April, she organised a video call with the applicant and architect stating that although raising the ridge is generally against Hillingdon's planning policy, there are many precedents for doing so in the neighbourhood. She added that the design seemed agreeable, especially the simple roof without dormers and the parallelism of the roof with the existing two gables. Consequently she advised that an application would likely be successful.

Since we have not yet received her written report, we apply on the basis of this verbal advice.
