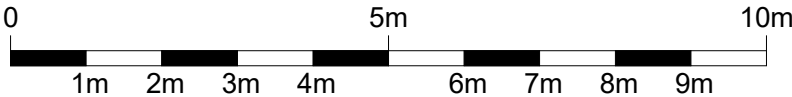


03 Roof Existing

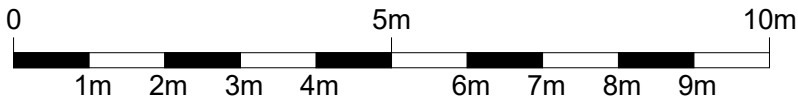

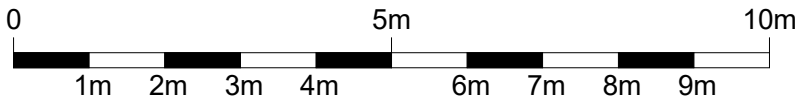

The proposed first-floor window has been revised in direct response to the refusal of application 45997/APP/2026/1747. The revised window has been reduced in scale and carefully designed to reflect the proportions, head height and architectural detailing of the other first-floor windows. As a result, the proposal preserves the visual balance, rhythm and proportional appearance of the first-floor elevation and does not result in a visually harmful or elongated appearance within the streetscene

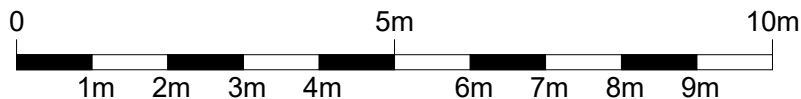


Rear elevation - Existing

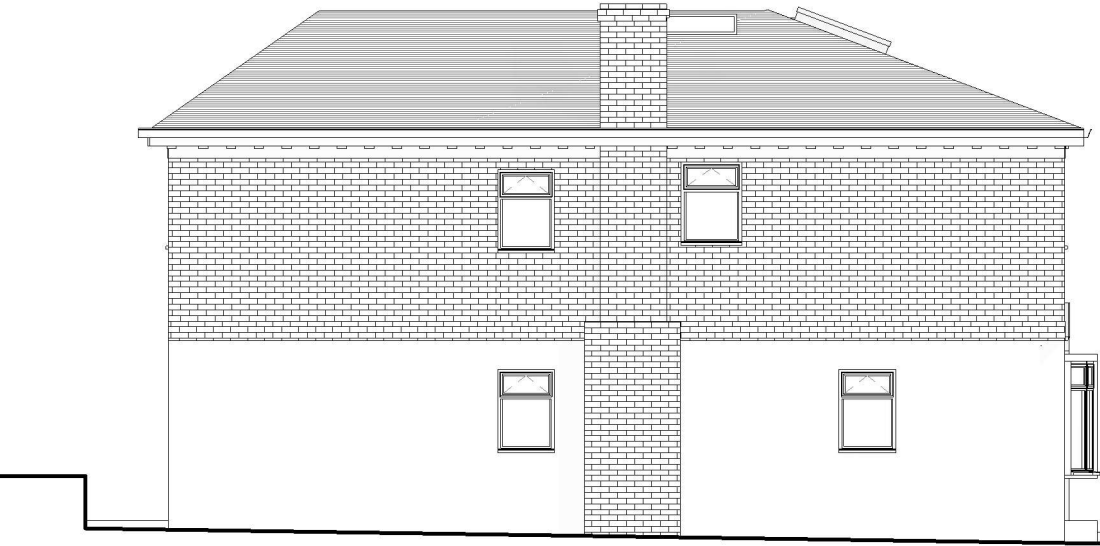
Side elevation 2 - Existing

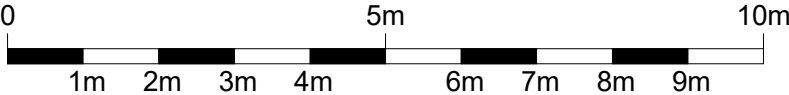
