Why do you consider that a Lawful Development Certificate should be granted for this proposal?

The proposed works comprise a rear dormer roof extension and rooflights to the front roof slope to allow the existing loft space to be converted into habitable accommodation. The property will remain as a single dwellinghouse.

The proposed dormer remains below the existing ridge height, is set back from the eaves, and the additional roof volume is within the allowance for a terraced house. The external materials will be similar in appearance to the existing dwelling, and no balcony, veranda or raised platform is proposed.

The proposal is therefore considered to fall within permitted development and a Lawful Development Certificate should be granted
