Details of the pre-application advice received

Concerns were highlighted that raising the roof and forming a crown roof would be contrary to council policy.

These items have now been omitted from the design.

There was concern that the two storey rear extensions could have a detrimental impact on the neighbouring properties and we were advised to show 45 degree lines from the neighbours windows.

Evidence has been provided as part of this planning application to show that the two storey elements will not breach the 45 degree rule.
