Details of the pre-application advice received

Any new application would need to be accompanied by detailed noise and odour information relating to the proposed flue/extract system. As a minimum this would need to include a noise assessment following the methodology set out in BS4142 and, with respect to odour, it would need to show that the design was consistent with best practice. These assessments would need to provide sufficient evidence that adverse effects would be been minimised so far as is reasonable, significant effects or nuisance would be avoided and provide sufficient detail of how this would be achieved through design and maintained through operation. You also need to confirm in your new application the proposed operating hours – Saturday has been described as 'late'.

To further assist your resubmission, we can see you have opted for a 'roof mounted horizontal' extract system, whereas a better design would show vertical discharging above eaves level. This will have to be considered in terms of its visual impact too – so when exploring your options please be mindful of this.
